

Re: Keeyask Project - Interim Water Power Licensing Application

Thank you for your recent letter dated February 8, 2012 where Manitoba Hydro filed an application with this office for an interim licence for the Keeyask Project.

My Water Power Licensing staff have reviewed the report and plans that were submitted in support of the application for an interim licence to use and store water for water power purposes at the proposed Keeyask Project site on the Nelson River. My staff have indicated that the application filed with the Department provides a good understanding of the project and that it fulfils the requirements of Section 3 of the Water Power Regulation\_(Regulation). The Department may request that Manitoba Hydro submit additional plans, data or information about the proposed project if it is determined that such additional plans, data, or information is required to complete our assessment of the project.

# **Manitoba Water Power Application**

On February 8, 2012, 5900345 Manitoba Ltd., the general partner on behalf of the Keeyask Hydropower Limited Partnership (KHLP), with its head office at 360 Portage Avenue, PO Box 815, Winnipeg, Manitoba, R3C 2P4, filed with the Assistant Deputy Minister, Water Stewardship Division, Department of Conservation and Water Stewardship an application for an Interim Water Power Licence under The Water Power Act (Manitoba) to permit the development of a hydroelectric generating station on the Nelson River to be known as the Keeyask Generating Station (GS). The KHLP is comprised of: general partner 5900345 Manitoba Ltd. and limited partners being Manitoba Hydro (MH), Cree Nation Partners Limited Partnership, York Factory First Nation Limited Partnership and Fox Lake Cree Nation Keeyask Investments Limited.

The Keeyask GS will be approximately 180 km (112 miles) northeast of Thompson, 60 km (37 miles) northeast of Split Lake, and 30 km (18.6 miles) west of Gillam. The Project will be located entirely within the Split Lake Resource Management Area. Water will be stored within a newly formed reservoir that will flood approximately 4500 hectares (11,120 acres) of provincial crown land and is predicted to expand by 700-800 hectares (1730-1980 acres) during the first 30 years of the project's operation. No privately owned land will be flooded.


An Environmental Impact Statement for the Keeyask GS was filed on July 6, 2012.

The proposed Keeyask GS is scheduled to start construction the summer of 2014 subject to regulatory licences and approvals. It will start generating power in 2019 and construction will be completed in 2022. The proposal provides for 695 MW (932,000 hp) of generation capacity and the energy produced will be sold to MH for inclusion in MHs Integrated Power System.

# Murder charge in blaze dropped

SECOND-DEGREE murder charge against a teen for the 2010 fire death of 11-year-old Edward Redhead in Shamattawa has been dismissed.

Senior Legal Aid defence attorney Gordon Bates, who represented the youth in court in Thompson, said evidence against him was "weak."

The Fire Commissioner's Office couldn't determine if the blaze was arson, said Bates. He said there was "some liquid" that burned in the home and was probably the origin of the fire, but how it arrived there was unproven.

"There was really no evidence linking him to any arson," he said, calling what happened a "complete tragedy."

Redhead died in a vacant home that caught fire in January 2010 in the northern Manitoba community.

People in Shamattawa were unable to reach the community's fire chief after the blaze broke out, and didn't realize Redhead was missing and killed in the fire until a couple of days later.

A Manitoba Justice spokesman confirmed the youth was acquitted of second-degree murder, but couldn't provide further comment due to a pub-

There are no other charges pending against anyone else for Redhead's death, said Bates.

# Refugee costs strain church groups

Federal cuts, mass arrival make it tough for newcomers

HEN they got together nearly a decade ago to sponsor refugees, a group of Winnipeg churches didn't expect it would take so long, they'd all arrive at once or that the federal government would cancel their medical benefits.

Now the neighbourhood churches say they're struggling to live up to their commitment as a surge of newcomers arrives.

"It's the looming costs of everything that escalate," said retired United Church minister Ken Anstie with the Nassau Street Churches Refugee Committee. He's scrambling to find housing for 10 Somalis who began arriving in November. The churches

— Crescent Fort Rouge United, St. Luke's Anglican, Holy Rosary Roman Catholic, Christian Science and Harrow United — have committed to helping them get settled and covering their living costs for one year.

"We try to put on fundraisers and people give personally," Anstie said.


But with a higher cost of living, aging congregations, refugees arriving in rapid succession and the federal government cutting their health benefits, it's getting tougher, the volunteer said.

Private sponsors were stunned when Citizenship and Immigration Canada announced it would no longer pay for refugees' prosthetics, prescriptions or dental and vision care as of June 30.

Had church officials known the federal government was going to renege on its commitment to pay for those expenses, they would have thought twice about all the sponsorships they committed to, Anstie said.

"It may mean in future private sponsorships will be cut back because of all the added expenses on top of basic costs like rent and heat."

Rev. Barb Janes at Crescent Fort Rouge United Church called it "despicable."

Volunteer Ken Anstie says if church groups had known the federal government was going to cut funding, they wouldn't have sponsored so many refugees.

She remembers Immigration Minister Jason Kenney meeting with church officials in Winnipeg and encouraging them to sponsor "Christian refugees from Iraq."

Kenney failed to mention cuts to

Kenney failed to mention cuts supplemental health benefits.

"What galls me is that at no point in that presentation did he say there was a plan to renege on the sponsorship agreement and stick the sponsors with health care costs," Janes said.

The health care needs of refugees are unknown before they arrive, she added.

"To think that refugee sponsors can A, diagnose these things and B, afford treatment is crazy," she said.

Before they arrive in Canada, refugees receive little if any medical

treatment, have a poor diet and live with improper sanitation, Janes said. "If they fled a war zone, they may well have injuries that have gone unattended," she said. "Some have faced

On June 30, Immigration backtracked and said it would continue to provide coverage to governmentassisted refugees but privately sponsored refugees are on their own.

Cyrilo Simpunga, who lost a leg in a machete attack in Congo, got a new prosthetic just before June 30. His sponsor, Hospitality House, is paying for expensive mediation to treat his ulcer.

The Catholic and Anglican churchfunded organization and the Diocese of Rupert's Land have taken the federal government to court for stripping new refugees of medical benefits such as prescription medicine and prosthetics

Hospitality House has to cover more costs while it's receiving more refugees.

"Our arrivals are up about onethird over last year," executive director Tom Denton said.

Most are from older sponsorship applications that are being processed now at beefed-up visa centres in Nairobi, Kenya and Cairo, Egypt, Denton said.

The federal government capped new sponsorship applications while it clears a backlog of refugee files.

"...Eventually, the visa posts do catch up on the old cases and the day

of reckoning comes," he said.

The refugees eventually arrive in Winnipeg.
"One never really knows until the

"One never really knows until the last minute," he said. "Typically, we get about 10 to 14 days' notice of an arrival, but we have had them in the recent past with as little as eight hours."

With a local vacancy rate near zero, it can take up to nine months to find long-term accommodation for the refugees, Denton said.

At one point last year, Hospitality House had 17 newcomers in its short-term receiving home, which normally houses nine, Denton said. They had to rent a second house.



# Red Sucker Lake boy, 4, dies of severe burns

WINNIPEG family members of a four-year-old boy who died from severe burns at a remote northern First Nation will get an opportunity to say a final farewell.

On Tuesday, the boy was playing at a home in Red Sucker Lake First Nation, 710 kilometres northeast of Winnipeg, when he came into contact with a flammable substance that ignited, RCMP said in a statement Friday.

The child had severe burns to 95 per cent of his body, Red

Sucker Lake Chief Les Harper said. RCMP did not name the flammable substance.

The boy was transported to hospital in Winnipeg where

Harper said off-reserve relatives in Winnipeg have been invited to the Aboriginal Funeral Home on Selkirk Avenue this evening to view the body and spend time with grieving family

"There's family that are in Winnipeg that can't go back to the reserve for a funeral. Sunday, we'll fly the casket home and then have a funeral Monday or Tuesday," Harper said.

A viewing where friends and relatives gather to say their farewells is a common aboriginal custom and for northerners it's not unusual to have an urban service, along with a service and burial at home.

RCMP do not suspect foul play. An autopsy has been completed and Island Lake RCMP, along with officials from the Manitoba Office of the Fire Commissioner have completed an investigation.

Harper wouldn't name the child but said he had a brother and twin baby sisters. His parents stayed with the boy at Children's Hospital until he died.

"I don't really know all the details. All I can say is we lost a boy and we're planning funeral arrangements." Harper added.

Lavoie would have to travel through the Diocese of Prince Albert in Saskatchewan to reach LaLoche in his own archdiocese.

The farthest point east he travelled is Sandy Lake, Ont., a fly-in and Northern Ontario Winter Road Network-only remote Oji-Cree First Nations community in Northwestern Ontario, 450 kilometres northeast of Winnipeg and 600 kilometres northwest of Thunder Bay.

The distance from the Bishop's House to Sandy Lake is a combined sixhour drive to Winnipeg, followed by a one- hour plane ride.

The farthest point north is Lac Brochet, reached by a four-hour drive from The Pas to Thompson and then an hour flight from Thompson to Lac Brochet. En route to Lac Brochet, Lavoie would sometimes stay at the rectory at St. Lawrence Church on Cree Road in Thompson overnight waiting to catch a morning flight and show up in church to help out the resident pastor here confessions, as he did March 19, 2008 before Easter.

Lavoie is perhaps the only archbishop to have received a photo credit for his pictures appearing in the Nickel Belt News.

The archbishop began the blog on Nov. 10, 2009 and the most recent entry is from last Oct. 27, recapping a weekend workshop and retreat a week earlier on Oct. 21-22 at St. Lawrence in Thompson, led by Armella Sonntag, regional animator for Saskatchewan/Keewatin Le Pas for the Canadian Catholic Organization for Development and Peace (CCODP).

Lavoie has also been known for his support of the annual Lac St Anne Pilgrimage in Alberta, about 75 kilometres northwest of Edmonton. This year's pilgrimage runs from July 22 to July 26. "First called Wakamne or God's Lake by the Nakota First Nations who live on the west end of the Lake and Manito Sahkahigan or Spirit Lake by the Cree, the lake was renamed Lac Ste Anne by Rev. Jean-Baptiste Thibault, the first Catholic priest to establish a mission on the site," says the Lac Ste. Anne Pilgrimage Company, the lay board the Oblates turned over the management and operation of the pilgrimage to a few years ago.

"The pilgrimage grounds had been sacred for generations of peoples and had become widely known as a place of healing. Aboriginal peoples camped on the site prior to contact with European fur traders and settlers," the board says. The pilgrimage was founded in 1887 by missionaries of the Oblates of Mary Immaculate. It has become the largest annual gathering of First Nations people in Canada. Last year close to 55,000 pilgrims, mostly aboriginal and Métis, made the Lac St Anne Pilgrimage.
