What is the Agreement on Internal Trade (AIT)?

The AIT is an interprovincial trade agreement that allows for the free movement of persons, goods, services and investments within Canada. As part of this agreement, the AIT allows any worker who is certified for a trade or occupation by a regulatory authority (i.e. government) in one province or territory to be recognized as qualified for that same trade or occupation by all other provinces and territories.

Which trades can be recognized in Manitoba based on the AIT?

For the purposes of AIT, Apprenticeship Manitoba will assess the credentials of workers who want to work in the Manitoba <u>compulsory</u> trades of Hairstylist, Esthetician, Electrologist, Crane and Hoisting Equipment Operator, Steamfitter-Pipefitter, Sprinkler System Installer, and Refrigeration and Air Conditioning Mechanic. People who work in these trades and have a Red Seal endorsement on a valid provincial Certificate of Qualification or have another equivalent credential can apply using this application form to have those credentials recognized so they can work in Manitoba.

People who are seeking recognition to work in the Manitoba <u>compulsory</u> trades of Construction Electrician or Industrial Electrician, should directly contact Inspection and Technical Services Manitoba, located at 508-401 York Avenue, Winnipeg, MB R3C 0P8 or visit **firecomm.gov.mb.ca/itsm_electrical.html**

What about trades not listed for AIT- based recognition?

People who are seeking recognition to work in Manitoba in all <u>voluntary</u> trades do not need to fill out this application form. Apprenticeship Manitoba does not produce documentation verifying credentials for voluntary trades because people who work in these trades can work in Manitoba without mandatory credentials. Employers who wish to verify the credentials of potential employees should contact the issuing jurisdiction directly, not Apprenticeship Manitoba.

What if I have Canadian military credentials?

People who hold Canadian military credentials corresponding to <u>voluntary</u> trades do not need to fill out this application form. For credentials corresponding to <u>compulsory</u> trades, fill out this form and indicate which credential you have and for which trade you are seeking recognition.

What if I just want a Red Seal endorsed certificate?

People who wish to obtain a Red Seal endorsed Certificate of Qualification in their trade can apply to Apprenticeship Manitoba through the Trades Qualification (TQ) process. Eligible applicants will be invited to challenge the certification examination.

NOTE: Some trades may also require an additional permit/license to practice. For more information, visit **manitoba.ca/tce/apprent/permits.**
