## Essential Items for Retail Sale - Detailed List



Manitoba's Chief Provincial Public Health Officer issued Public Health Emergency Orders on November 21, 2020, declaring that a retail business may open but it may only sell essential items to members of the public who are shopping in person at the business. New Public Health Emergency Orders are in force effective December 12, 2020. These orders allow retailers to sell "seasonal items" to in-person shoppers in addition to essential items. The orders also refined the list of essential items. Under the orders, the operator of a retail business must ensure that:

- non-essential items are removed from areas of the business to which members of the public have access;
- members of the public are physically prevented from gaining access to non-essential items at the business; or
- signs in the business or stickers on items clearly identify non-essential items that cannot be purchased.

The new Public Health Emergency Orders exempt thrift stores from the prohibition on selling non-essential items to in-person shoppers. If a retail business primarily sells used clothing, footwear or household articles, it may sell non-essential items to in-person shoppers.

The orders are in force until January 8, 2021. After this date, please consult manitoba.ca/covid19 for information about the application of public health orders to retail businesses.

The document below is intended to provide guidance to retail businesses by listing examples of what may be considered essential, non-essential and seasonal items under the Public Health Emergency Orders. This is not intended to be an exhaustive list, and is for guidance purposes only. Further, the list may be revised from time to time for clarification or in the event that the Public Health Emergency Orders are amended. This list is intended to assist retailers in identifying what items they may offer for sale to in-person shoppers. Retailers may continue to offer non-essential items (in addition to essential items and seasonal items) for sale online, by telephone or other remote means for delivery or pick-up.

8. Household cleaning products	laundry detergent, fabric softener, dish soap, bleach, cleaning agents, cleaning cloths and brushes, mops and brooms, vacuums and air fresheners	
9. Household safety and protection products	smoke alarms, carbon monoxide detectors, firewood, flashlights, lighters and survival candles, portable heaters and fire extinguishers	
10. Batteries and light bulbs	batteries and lightbulbs	
11. Clothing	winter jackets, snow pants, underwear, winter headwear, gloves and mitts, socks, pantyhose, and winter boots	footwear (excluding winter boots), non-seasonal clothing for adults and children
12. Personal protective equipment and protective clothing for use in the workplace	masks, respirators, gloves, safety glasses or goggles, safety, tactical or combat boots or shoes, overalls and protective aprons, protective headgear, reflective clothing and medical uniforms and scrubs	non-protective work uniforms and sunglasses
13. Tobacco products	cigarettes, chewing tobacco, lighters	vape products
14. Pet food and supplies	pet food, bird feed, food and water bowls, collar, leash, ID tags, animal health products (nail clippers, first aid supplies, toothbrush and toothpaste) carriers, kitty litter, training pads and diapers, grooming supplies. This includes the sale of live pets	pet toys, animal training supplies and pet furniture, such as a bed
15. Postage stamps and mailing supplies	postage stamps, boxes, envelopes, packing tape, mailing labels, bubble wrap and packing paper

17. Parts and supplies for all types of motor vehicles and watercraft	various parts and supplies for all types of motor vehicles and watercrafts (including ATV's and motorcycles)	air fresheners, ashtrays, seat and steering wheel covers, floor mats, and sunshades
18. Major household appliances	refrigerators, freezers, kitchen stoves, microwave ovens, toaster ovens, dishwashers, washing machines, clothes dryers and air conditioning units	coffeemakers, electric kettles, toasters, blenders, stand mixers, food processors, crockpots, and pressure cookers
19. Hunting, fishing and trapping supplies	sonar and GPS devices, firearms, ammunition, rods and reels, binoculars, rangefinders, crossbows, bait, life jackets, knives and knife-sharpening equipment	non-protective clothing, footwear, camping grills and cooking stoves (may be considered small household appliances), camping cots, fire pits and backpacks
20. Tools and hardware	small and large power tools, wrenches, screwdrivers, hammers, tape measures, screws, nails, door knobs, hinges, levels, and similar type items

Materials, parts and components for the maintenance, repair or construction of residential or commercial building systems	plumbing, electrical and lighting, heating, cooling and ventilation systems such as generators, wood, propane or similar heating sources. Material used for the construction of residential and commercial buildings. Including interior finishes such as flooring, lighting, paint, flooring, carpeting, etc	decorative items such as blinds and curtains
22. Products related to property maintenance	shovels, brooms, snow blowers, sand and road salt	plants, gardening supplies and yard decorations

## **Seasonal Items Exemption:**

Allowing in-person sales of seasonal decorations such as trees, garland and ornaments, religious items such as menorahs and candles.

Seasonal Items	indoor and outdoor holiday decorations, Christmas trees, wreaths, poinsettias, gift wrap, gift bags, tissue paper, tags, bows, greeting cards and seasonal religious items such as menorahs and holiday or religious candles	toys, clothing, other items traditionally exchanged as gifts or seasonal sporting equipment such as hockey skates, skis, toboggans or snowshoes

## Other Non-essential Items

	NON-ESSENTIAL
Houseware and tableware	plates, bowls, glassware, flatware (forks, spoons, knives), mugs, bakeware, small appliances such as a coffee pot, toaster, waffle makers, decorative items, linens and towels (bathroom linen, bedroom linen, curtains, cushion covers, placemats, tablecloths, pillows, picture frames, framed art and similar items
Furniture	couches, mattresses, bed frames, chairs, tables, desks, nightstands, home storage, waste baskets and similar items
Office supplies	calendars, planners, staplers, paperclips, post-it notes, desk organizers, paper shredders, hard drives, USB/flash drives, whiteboards, toner, ink cartridges, printers, copiers, computers, monitors, and other consumer electronic products
Electronics	computers, tablets, printers, video game consoles, televisions, speakers and smart home devices, radios, audio/video/data power cables and similar items and related accessories
Hobby, craft and art supplies	non-commercial paint, sewing machines, fabric, beads, jewellery, yarn, artist's canvas, sketchbooks, art desks and easels, clay and sculpting supplies and thread and similar materials for sewing
Other items	dehumidifiers, air purifiers, water coolers, musical instruments, jewellery, flowers, perfume, consumer electronics, sporting equipment, books and toys
