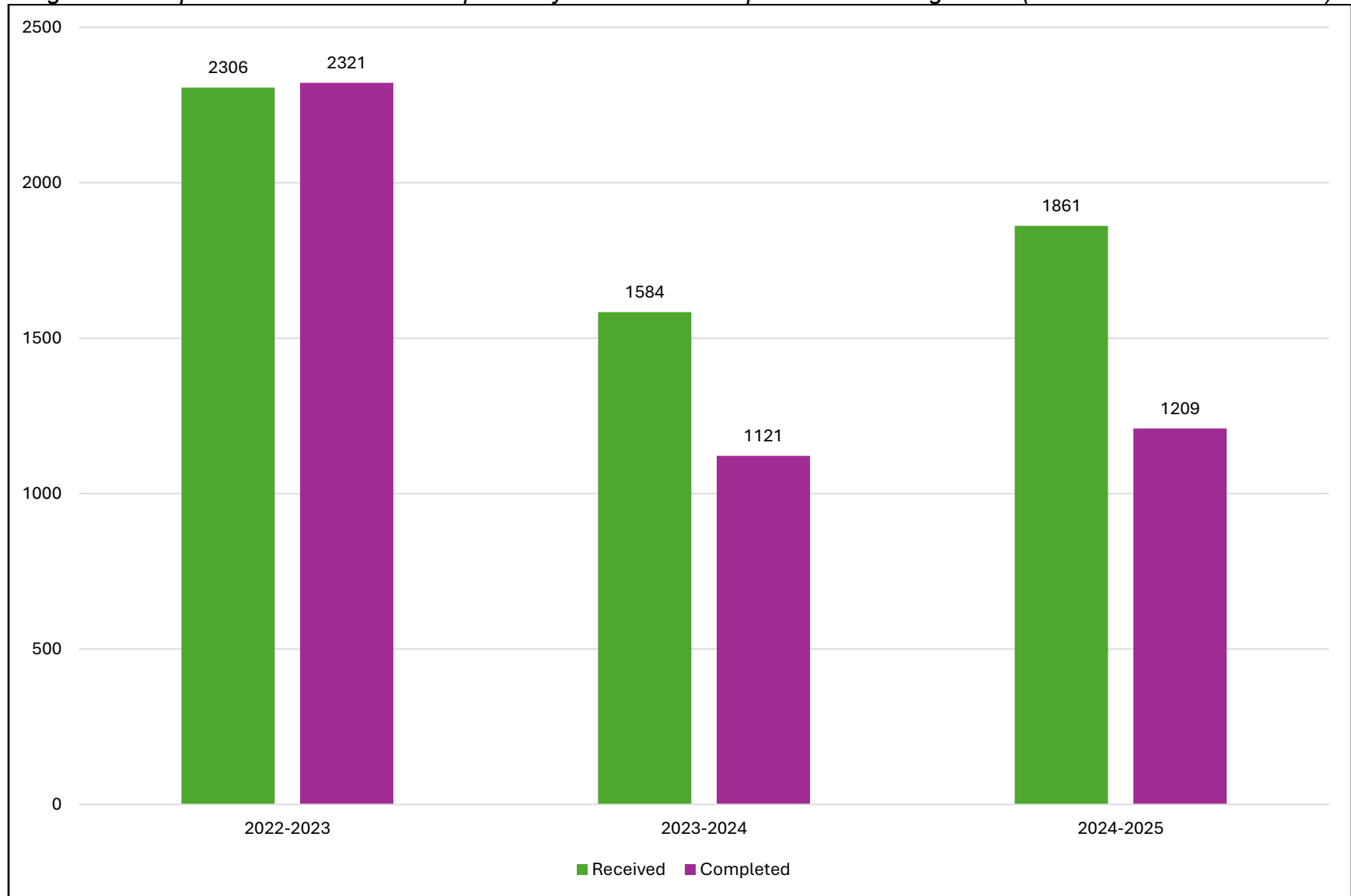

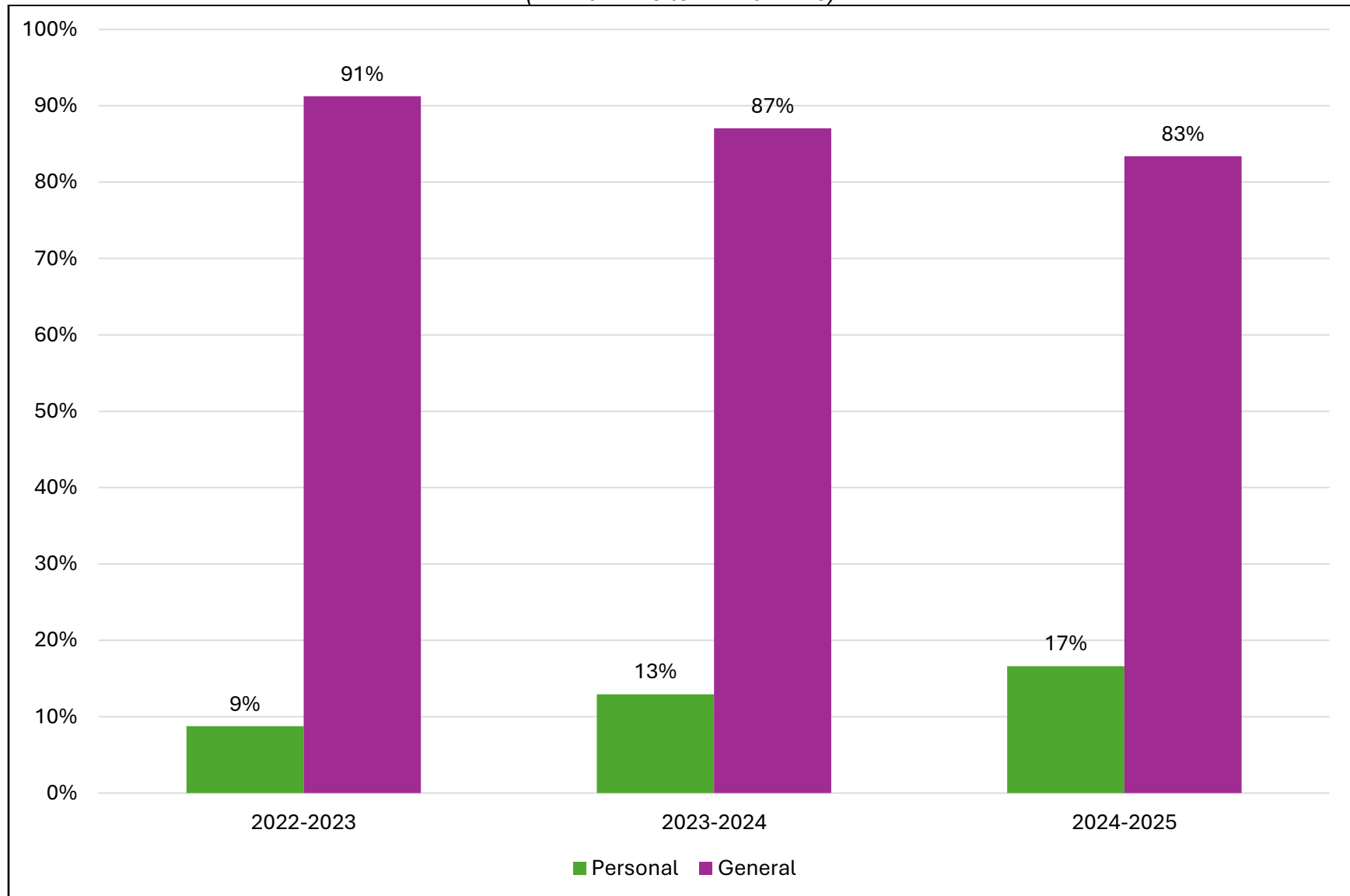

(FY 2022-23 to FY 2024-25)*

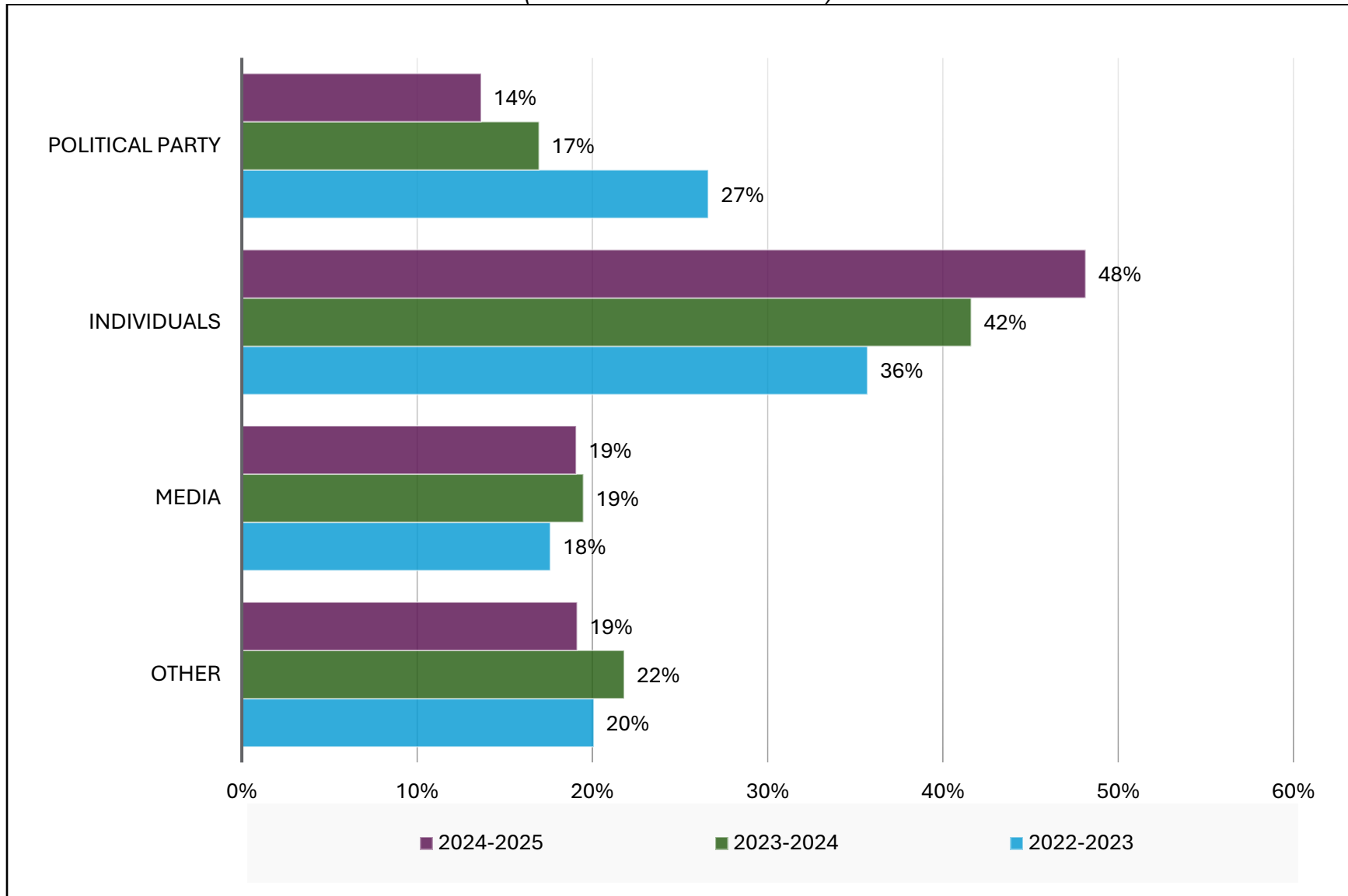


Figure 4 – Access Decisions - Government Departments and Agencies (FY 2022-23 to FY 2024-25)

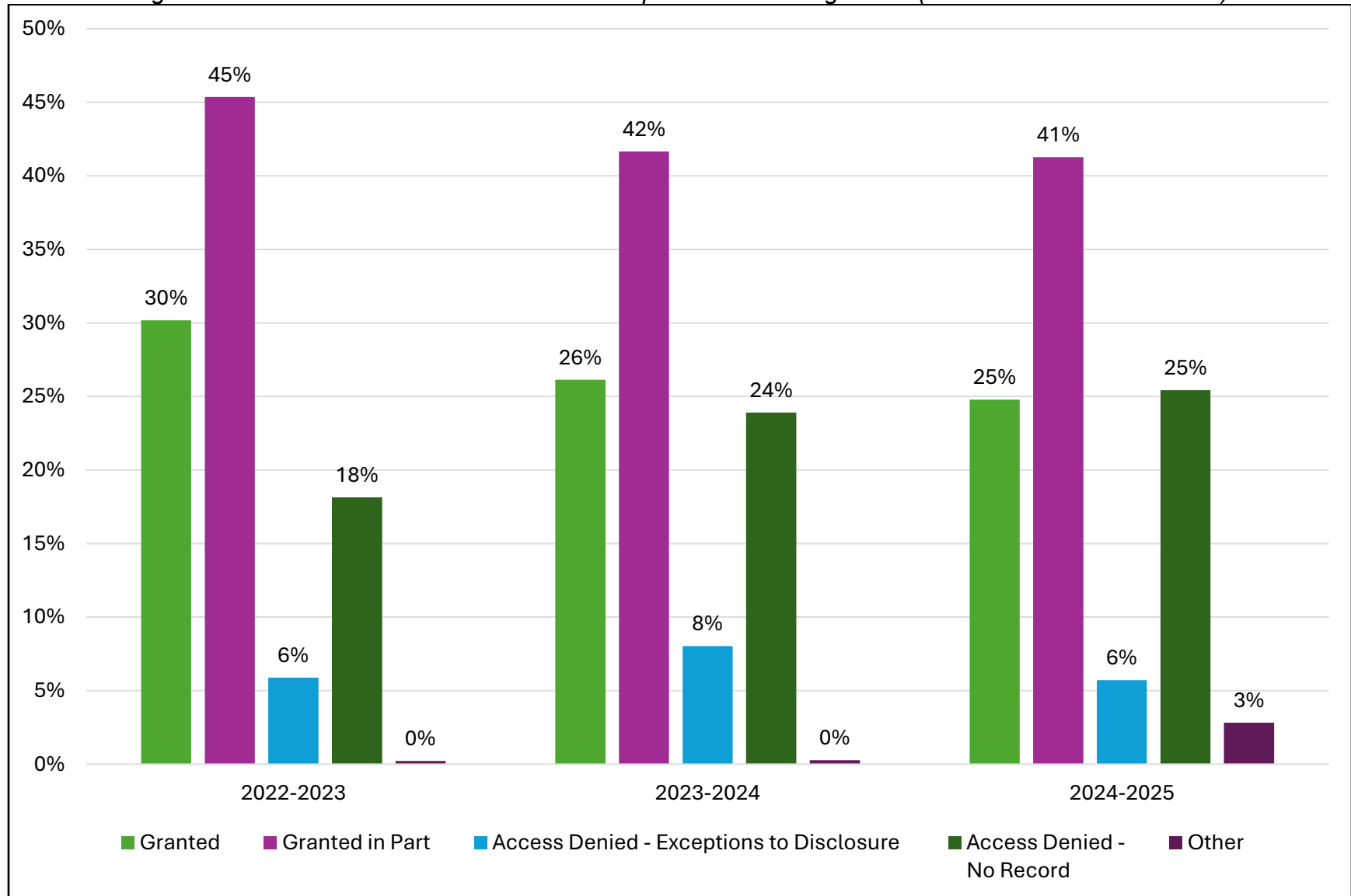

Figure 5 – Fees Collected by Government Departments and Agencies (FY 2022-23 to FY 2024-25)

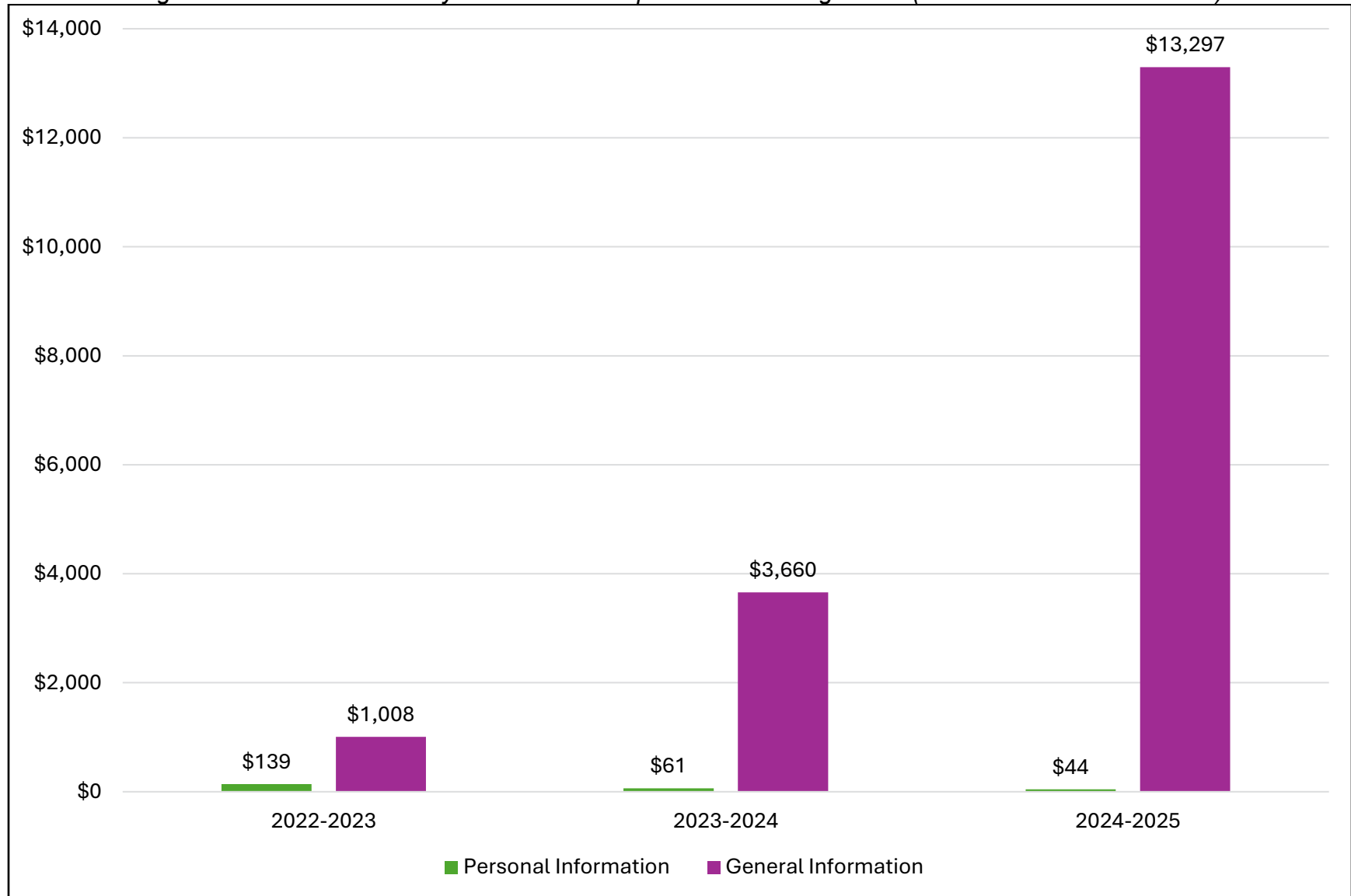
