

Rent

- 1. The **MHRC Market Rent** is the value of the unit when unsubsidized. The MHRC Market Rent for the catchment area is reviewed and may be adjusted annually.
- 2. The program **Rent Subsidy** is the program benefit calculated as the difference between the stated **MHRC Market Rent** and the **Program Base Rent**; this benefit is supported by public funds.
- 3. Total Monthly Payable includes all additional fees, as applicable.
- 4. The tenant agrees to pay the **Total Monthly Payable** by the 1st day of every month.
- 5. Tenants must immediately inform the landlord of changes which would result in a change to their level of rent subsidy. This may include but is not limited to a change in income or change in household composition.
- 6. Tenants must provide complete documentation to support the process of setting the amount of approved rent subsidy. If documentation is not provided it will result in removal of rent Subsidy.
- 7. When rent Subsidy is removed, the tenant shall pay MHRC Market Rent, plus any applicable fees.
- 8. Manitoba Housing shall not increase the MHRC Market Rent for a rental unit without giving the tenant a written notice of the intended rent increase at least three months before the effective date of the increase.

Responsibilities and Obligations:

Violations of the following policies will result in removal of rent subsidy:

- Guest
- House Rules Agreement
- Long Term Absence
- Outstanding Balance at End of Tenancy
- Over or Under Housed
- Providing False Information
- Subsidy Agreement

As per section 103 of The Residential Tenancies Act, when a tenant ceases to be eligible for the particular rental unit he or she occupies in subsidized housing, the landlord may terminate the tenancy.

Manitoba Housing will make every reasonable effort to make available a rental unit for which the tenant is eligible in the vicinity of the rental unit that the tenant occupies.

To remain eligible for subsidized housing a tenant must have a total adjusted household income at or below the Program Income Limits established by Manitoba Housing.
