# CONSENT TO WITHDRAWAL AS A RESULT OF DISABILITY UNDER THE POOLED REGISTERED PENSION PLANS (MANITOBA) ACT

UNDER THE POOLED REGISTERED PENSION PLANS (MANITOBA) ACT

I understand that under the Act:
<ul> <li>Because the member is disabled, the member may withdraw the funds in his or her pooled registered pension plan account as a lump sum.</li> </ul>
<ul> <li>My written consent is needed to allow the member to withdraw the funds.</li> </ul>
<ul> <li>If I sign this consent, the funds will no longer be available to me</li> </ul>
<ul> <li>as a 60% joint life annuity if the funds are transferred into an annuity before the member dies;</li> </ul>
• as a survivor benefit or death benefit, if the member dies before the funds are transferred into an annuity; or
<ul> <li>as a spouse, former spouse or common-law partner, if the funds are divided under the Ac because of a breakdown of the relationship.</li> </ul>
I certify that:
I have read this consent and understand it.
• I have read the statement provided under section 12 of the Regulation.
<ul> <li>I am aware of the consequences of consenting to the withdrawal and consent to the withdrawal despite of the consequences.</li> </ul>
<ul> <li>I am not living separate and apart from the member by reason of a breakdown of our relationship.</li> </ul>
<ul> <li>The member is not present while I am signing this form.</li> </ul>
<ul> <li>I am signing this consent of my own free will without duress, coercion or compulsion of any kind.</li> </ul>
• I realize that this form only gives a general description of the legal rights I have under the Act and the Regulation, and if I want to understand exactly what my legal rights are, I must read the Act and the Regulation and seek legal advice.
I hereby consent to the lump sum withdrawal as a result of disability by signing this form in the presence of a witness.

## **COMMENTS AND INSTRUCTIONS**

This form must be completed by the cohabiting spouse or common-law partner of a member if the member wants to withdraw the funds in his or her pooled registered pension plan (PRPP) account as a lump sum because of disability.

Before completing this form, you should consider obtaining independent legal advice and speak to a financial advisor who can explain the implications of this consent.

This form must be

- completed in its entirety;
- signed by the member's cohabiting spouse or common-law partner while the member is not present;
- witnessed;
- filed with the administrator; and
- used for funds in a PRPP subject to The Pooled Registered Pension Plan (Manitoba) Act.

#### **Definitions for the Purpose of this Consent**

**Administrator** means the administrator of the applicable pooled registered pension plan.

**Cohabiting spouse or common-law partner** means a spouse or common-law partner from whom the member is not living separate and apart by reason of a breakdown of the relationship.

## **Disability** means

- (a) with respect to a withdrawal under subsection 10(1) of *The Pooled Registered Pension Plans (Manitoba) Act*, a life expectancy that has been shortened by reason of a terminal illness or disability to less than two years; or
- (b) with respect to a withdrawal under an optional contractual provision in a PRPP allowed under paragraph 47(2)(a) of the *Pooled Registered Pensions Act* (Canada), a mental or physical condition that a physician has certified as being likely to shorten considerably the life expectancy of the member,

**60% joint life annuity** means the joint life annuity to which a cohabiting spouse or common-law partner is entitled under section 9 of *The Pooled Registered Pension Plans (Manitoba) Act*. This annuity provides a survivor pension to the cohabiting spouse or common-law partner that is 60% of the pension paid during the member's lifetime.

**Member** means a person with a PRPP account subject to *The Pooled Registered Pension Plans (Manitoba) Act.*
