
**Notice of Sale of Real Property for Unpaid Taxes**

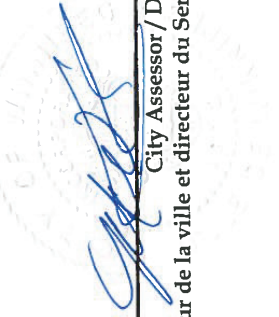
