| | WHEREAS it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on January 26, 2016 a 4 year old child enrolled at the St. James Y Family Child Care (the "Centre") was left unsupervised by Centre Staff in the school age room of the Centre. The Centre's incident reports were requested and reviewed by MELCC. The reports described how a Centre Staff (#1) covering another Centre Staff's (#2) lunch break, was left in charge of a group of 8 preschool children. This Centre Staff (#1) however thought she was supervising 7 children as she was unaware that an 8 th child had fallen asleep in the "library area" of the room. At approximately 12:56 p.m. this Centre Staff (#1) took the 7 preschool children from the school age room to the adjoining "play structure" room and left the 4 year old child who was still asleep, in the school age room. It was also reported that when the Centre Staff (#2) returned from lunch and met up with her group in the "play structure" room, it was discovered that the 4 year old was not with the group. The Centre Staff (#1) immediately returned to the school age room and found the preschool child asleep in the "library area". | |
