| | WHEREAS it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on May 15, 2013 at approximately 11:30 a.m. Becky McGregor-Dyck and Cheryl Rossin (the "Licensees") and 11 children that were attending the group child care home, were outside in the yard of the child care located at 495 Whitmore Avenue West, Dauphin Manitoba. While outside, a two year old child wandered away from the yard. The licensees indicated they thought the child squeezed through an opening in the fence surrounding the yard. | |
| | It was also reported to MELCC that at 11:55 a.m. on May 15, 2013, the RCMP in Dauphin received a call that a young child was found wandering by the CO-OP gas bar, unaccompanied by an adult. At approximately 12:40 p.m. after the RCMP was unable to determine where the child had come from, the child was taken to Michif Child & Family Services. | |
| | Subsequently, RCMP received a call from Becky McGregor-Dyck at 1:05 p.m. to report that a child had gone missing from the group child care home. RCMP informed her that the child had been located and was in the care of the Michif Child & Family Services. | |
