	WHEREAS on June 28, 2013 a report was made to Manitoba Early Learning and Child Care ("MELCC") of an incident that occurred on June 24, 2013 in which two preschool children attending Shilo MFRC Daycare (the "Centre") went missing for approximately forty-five (45) minutes, while on an outing in the Sprucewoods Wildlife Refuge located adjacent to CFB Shilo.	
	The Centre reported that on June 24, 2013, two Centre staff and 11 pre-school children went on a walk in a forested area near the Centre. During the walk, two three year old children ran ahead of the group. A Centre staff called out to them to come back for a snack. Once all the children were seated, Centre staff noticed the two children had not returned to the group.	
	When Centre staff could not immediately locate the children, the Shilo Military Police were contacted for assistance in locating them. Centre staff found the two children hiding in the forest approximately forty-five minutes after it had been noticed they were missing.	
	AND WHEREAS, the licensee fails to meet <i>The Community Child Care Standards Act</i> and Manitoba Regulation 62/86 as hereinafter provided.
