	WHEREAS it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on January 31, 2013, while on a field trip to the YMCA of Brandon, a 30 month old child from the Y Downtown Early Learning Centre (the "Centre") wandered away from the group unnoticed by Centre staff. The YMCA building is located across the street from the Centre.	
	As reported to MELCC by the Centre, at approximately 11:30 a.m., thirteen children and three Centre staff prepared to return to the Centre for lunch. As several children were dressed in their winter clothes and ready to leave, it was decided that two Centre staff would return to the Centre with a smaller group of children. Before this group left the building, Centre staff did not notice a 30 month old child wander away.	
	The third Centre staff and the second group of children arrived at the Centre several minutes after the first group. At that time a Centre staff noticed the 30 month old child had not arrived with the group. When asked where the child was, the Centre staff stated she thought the child had returned to the centre with the first group of children.	
	A Centre staff immediately returned to the YMCA to search for the missing child. A staff from the YMCA also assisted in a search of the building. The child was found in the "babysitting room".
