This information notice provides information regarding filing provincial tax returns and receiving provincial tax refunds during a postal disruption.

SECTION 1 – FILING PROVINCIAL TAX RETURNS:

Retail Sales Tax Act:

Retail Sales Tax returns must be filed by the due date, regardless of a postal disruption. Returns and payments can be made online at www.manitoba.ca/TAXcess or businesses eligible to file a paper tax return can drop it off at the Taxation Division office listed below.

Other Provincially Administered Taxes:

Corporation Capital Tax, Mining Tax and Emissions Tax on Coal and Petroleum Coke returns must be filed by the due date, regardless of a postal disruption. Tax returns can be dropped off at the Taxation Division office listed below.

All other provincial tax returns and payments are required to be filed online at www.manitoba.ca/TAXcess. The due dates remain unchanged.

SECTION 2 – RECEIVING PROVINCIAL TAX REFUNDS:

During the postal disruption, provincial tax refund cheques will be available for pick-up at locations throughout the province.

In Winnipeg, provincial tax refund cheques will be available in the basement auditorium at 401 York Avenue from 8:30 to 4:30 Monday to Friday. A piece of photo identification or two pieces of non-photo identification with your current address will need to be presented to receive your provincial tax refund cheque. For representatives picking up tax refunds on behalf of a business, a completed [Authorization or Cancellation of a Representative](#) form is also required.

Refunds issued by direct deposit are not impacted.
