2024/25	Major	A patient experienced a change in their health status as a result of a medication administration issue.
2024/25	Major	Gaps in monitoring led to delay in diagnosis and treatment of an acute medical condition.
2024/25	Death	A patient experienced a clinical deterioration in their medical condition. Opportunities for earlier recognition and intervention were not realized.
2024/25	Major	A patient developed skin tissue breakdown. Opportunities for earlier intervention were identified.
2024/25	Major	An unintended medication was provided that resulted in the need for emergency intervention.
2024/25	Death	A patient inflicted serious self-harm. The opportunity to mitigate the risk was not recognized.
2024/25	Major	Client developed a stage 3 pressure injury while in care.
2024/25	Major	A resident experienced skin tissue breakdown related to a medical device requiring increased care and intervention.
2024/25	Major	Gaps in monitoring led to delayed recognition and response to a clinical deterioration.
2024/25	Major	A patient experienced skin tissue breakdown requiring increased care and intervention. Early opportunities to provide intervention were not consistently realized.
2024/25	Major	A resident fell resulting in a fracture and lacerations.
2024/25	Major	A patient inflicted self-harm which required an escalation of care.
2024/25	Death	A patient presented to the emergency department, was discharged home, and later returned via ambulance.
2024/25	Major	A patient experienced an unplanned hospital admission following a medical procedure.
2024/25	Death	A patient experienced a change in their medical condition. Opportunities for earlier recognition and intervention were not fully realized.
2024/25	Major	A delay in patient diagnosis/treatment was associated with serious harm.
2024/25	Major	A patient sustained an acute medical condition after a misinterpretation of a medication order.
2024/25	Major	A resident experienced an injury. Opportunities to mitigate the risk were not fully realized.
2024/25	Major	A patient experienced a missed diagnosis that led to a delay in treatment.
2024/25	Major	A resident experienced an injury. Opportunities to mitigate the risk of injury were not fully realized.
2024/25	Major	A patient required an unplanned admission to hospital as a result of missed opportunities to recognize and respond to an acute medical condition.
2024/25	Major	A patient experienced a delay in diagnosis of an acute condition which led to an unusual extension of their hospital stay.
2024/25	Major	A patient presented to the emergency department and diagnostic testing was completed. There was a gap in reviewing the results in a timely manner and the patient left without having appropriate care initiated.
2024/25	Major	A patient sustained an injury while admitted to hospital, requiring additional care and intervention.
2024/25	Major	Client developed a stage 3 pressure injury while in care.

2024/25	Major	A patient experienced unintended side effects from a medication. The opportunity to adjust the medication based on the patient's medical history was not realized.
2024/25	Major	A resident experienced an injury. Opportunities to mitigate the risk were not fully realized.
2024/25	Major	A client received an unintended medication resulting in an unplanned admission to hospital.
2024/25	Major	A resident experienced an injury. Opportunities to mitigate the risk of injury were not fully realized.
2024/25	Major	Client developed a medical device related pressure injury while in care.
