RESOLVED that a sum not exceeding Twenty-Nine Million Dollars (\$29,000,000.00), being Fifty Percent (50%) of the total amount to be voted as set out in Part B (Capital Investment) of the Estimates, be granted to Her Majesty for the Fiscal Year ending the 31st day of March, 2003.
