Mr. BOROTSIK moved:

Resolution No. 1: Making Manitoba a "Have" Province

WHEREAS Manitoba is now the only "have not" province in Western Canada; and

WHEREAS Manitoba is not immune to the negative effects of a global financial crisis rooted in the mismanagement of financial resources; and

WHEREAS a strong indicator of a jurisdiction's prudence and accountability is the Provincial Government's ability to live within its means and balance its operating budget; and

WHEREAS this Provincial Government has passed legislation that allows it to run operating budget deficits without consequence; and

WHEREAS for Manitoba to move from "have not" to "have" status will require a positive business environment for entrepreneurs and business owners; and

WHEREAS this Provincial Government, in a global economic crisis, has passed legislation that has created a climate of fear and uncertainty among many family farmers, investors, entrepreneurs and workers; and

WHEREAS many Manitobans are exercising financial restraint during this period of economic downturn; and

WHEREAS this Provincial Government passed legislation that directs taxpayer revenue to the New Democratic Party of Manitoba; and

WHEREAS a bold and innovative vision is needed to take Manitoba from "have not" to "have" status, and no such vision is evident in any of this government's Throne Speeches or budgets; and

WHEREAS this Provincial Government has instilled neither spirit nor energy in developing a long term vision for Manitoba's future as a "have" province; and

WHEREAS receiving money from external and fluctuating sources of revenue is neither prudent nor visionary; and

WHEREAS Manitoba has become significantly more dependent on equalization payments from the Federal Government; and

WHEREAS Manitoba is currently receiving an unprecedented amount of equalization payments from the Federal Government; and

WHEREAS Manitobans are weary from the dependence on our neighbors that has grown under this Provincial Government and want to see Manitoba become economic leader in Canada.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to consider acknowledging that being a "have not" province is not acceptable and that is not in the best interests of the Province of Manitoba; and

THEREFORE BE IT FURTHER RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to consider - after being in government for nine years - accepting the challenge to making Manitoba a "have province".
