Mr. DYCK – Legislative Assembly of Manitoba to request the Minister of Health to strongly consider giving priority for funding to develop and staff a new 100 bed long-term-care facility so that clients are not exposed to unsafe conditions and so that Boundary Trails Health Centre beds remain available for acute care patients instead of waiting placement clients. (D. Barkley, A. Lone, P. Olafson and others)

Mr. LAMOUREUX – Legislative Assembly of Manitoba to request that the Premier and the NDP Government to call a meeting of a Standing Committee of the Legislature and invite representatives of the WRHA to appear before it. (J. Joss, N. Rena, C. Goldenstein and others)

Mr. BRIESE – Legislative Assembly of Manitoba to urge the Minister of Health to consider prioritizing the needs of these communities by ensuring they have access to a family doctor and to consider promptly increasing the use of nurse practitioners in these communities in order to improve access to quality health care.
