Resolution No. 24: 100th Anniversary of B'nai Brith in Manitoba

WHEREAS B'nai Brith has had a presence in Canada since 1875 and is the Jewish community's senior advocacy and community service organization in this country; and

WHEREAS 2009 marks the hundredth year of B'nai Brith's establishment in Manitoba; and

WHEREAS B'nai Brith is a human rights organization that works to combat antisemitism, racism and hate while promoting interfaith and intercultural dialogue and respect among all Manitobans, and

WHEREAS B'nai Brith's mandate in Manitoba includes support and assistance for vulnerable communities and providing important community action based on and derived from a strong sense of Jewish culture and spirituality; and

WHEREAS this includes fostering remembrance of and broad community education on the Holocaust; and

WHEREAS since its inception B'nai Brith has continuously contributed to the growth of a vibrant Jewish community in Manitoba.

THEREFORE BE IT RESOLVED THAT the Legislative Assembly recognize the 100th Anniversary of B'nai Brith's important and ongoing human rights and social justice advocacy, as well as the cultural contributions it has made to Manitoba.
