Mr. GOERTZEN moved:

Resolution No. 35: Enhancing Respect for Manitobans

WHEREAS the Legislative Assembly of Manitoba provides any Manitoban the opportunity to make a presentation at committee regarding proposed legislation; and

WHEREAS this input from Manitobans often results in improvements to legislation and is an important democratic right; and

WHEREAS some Provincial Government Ministers continue to disrespect Manitobans by paying more attention to their electronic devices during committee hearings than the presenting public at these committees; and

WHEREAS some Provincial Government Ministers have disrespected Manitobans presenting at committee by labeling those opposed to their legislation as "howling coyotes"; and

WHEREAS some Provincial Government Ministers have disrespected Manitobans by publicly stating, even before committee hearings on legislation, that they are unwilling to listen to presenters who disagree with their legislation.

THEREFORE BE IT RESOLVED that the Legislative Assembly commend those Manitobans who exercise their democratic right by making presentations to committee on proposed legislation; and

BE IT FURTHER RESOLVED that the Legislative Assembly of Manitoba urge Provincial Cabinet Ministers to refrain from insulting, ignoring and disrespecting Manitobans who make presentations to committee in opposition to their proposed legislation.

Pursuant to Rule 26(1), Messrs. JHA, EWASKO, WIEBE and WISHART and Ms. CROTHERS made Members' Statements.

Prior to Grievances, Mr. EWASKO rose on a Matter of Urgent Public Importance and moved:

THAT in accordance with Rule 36(1), the regularly scheduled business of the House be set aside to discuss a Matter of Urgent Public Importance, namely, the Provincial Government's violation of the Freedom of Information and Privacy Protection Act's Section 23.1(a) redaction powers to protect itself from Ministers who utter remarks that are inappropriate and the need for the Ombudsman to investigate the violation.

And Hon. Ms. HOWARD having spoken to the urgency of the motion,

WHEREUPON Mr. Speaker ruled as follows:

I thank the Honourable members for their advice to the chair on whether the motion proposed by the Honourable Member for Lac du Bonnet should be debated today. The notice required by Rule 36(1) was provided. Under our rules and practices, the subject matter requiring urgent consideration must be so pressing that the public interest will suffer if the matter is not given immediate attention. There must also be no other reasonable opportunities to raise the matter.

I have listened very carefully to the arguments put forward by Honourable Members, however I was not persuaded that the ordinary business of the House should be set aside to deal with this issue today. Although this is an issue that some Members may have concerns about, I do not believe that the public interest will be harmed if the business of the House is not set aside to debate the motion today.

Additionally, I would like to note that other avenues exist for Members to raise this issue, including Question Period and Members' Statements, and in fact this issue has been raised in Oral Questions over the past several days.

Therefore, with the greatest of respect, I must rule that this matter does not meet the criteria set by our Rules and Precedents and I rule the motion out of order as a Matter of Urgent Public Importance.

THAT the motion be amended by deleting all the words after the word "THAT" and substituting the following:

Bill (No. 20) – The Manitoba Building and Renewal Funding and Fiscal Management Act (Various Acts Amended)/Loi sur le financement du renouvellement des infrastructures et la gestion financière (modification de diverses dispositions législatives), reported from the Standing Committee on Social and Economic Development, be not concurred in and read a Third Time but that it be concurred in and read a Third Time this day six months hence.

And the debate continuing on the amendment,

And Mr. PEDERSEN, Mrs. STEFANSON and Mr. HELWER having spoken,

The debate was, on motion of Hon. Ms. HOWARD, adjourned.

During the debate, Mr. GOERTZEN rose on a point of order regarding the lack of Government Members debating Bill (No. 20).

And Hon. Ms. HOWARD having spoken to the point of order,

WHEREUPON Mr. Speaker ruled that there was no point of order.

From his decision, Mr. GOERTZEN appealed to the House,

And the Question being put, "Shall the ruling of the Chair be sustained?" It was agreed to, on the following division:
