PRAYER 1:30 O'CLOCK P.M.

The Clerk formally advised the Assembly that the Speaker was unavoidably absent and called upon the Deputy Speaker to take the Chair pursuant to the Statutes. The Deputy Speaker took the Chair at 1:30 p.m.

Immediately following the Prayer, the House resumed contributions to a Matter of Privilege raised by Mrs. SMITH (Point Douglas) on March 16, 2020 regarding the Government's failure to proclaim *The Advocate for Children and Youth Act*,

And Mrs. SMITH (Point Douglas) having spoken and moved:

THAT this matter be moved to an all party committee for consideration.

And Hon. Messrs. GOERTZEN and GERRARD having spoken,

WHEREUPON the Deputy Speaker informed the House he would take the matter under advisement.

Subsequently following the Prayer, Mr. WIEBE rose on a Matter of Privilege regarding misstatements by the Government regarding the strategic infrastructure budget, specifically regarding flood mitigation and moved:

THAT this matter be referred to a Committee of this House.

WHEREUPON The Deputy Speaker informed the House he would take the matter under advisement.

Subsequently following the Prayer, Mr. LINDSEY rose on a Matter of Privilege regarding the Government's attempt to enforce legislation that has not yet been proclaimed, more specifically Bill No. 28 and moved:

THAT this issue be immediately referred to a Committee of this House.
