Resolution No. 5: Reducing Barriers for Ukrainians Seeking Refuge

WHEREAS on February 24th, 2022 the country of Ukraine was attacked with a full-scale military invasion by Russia; and

WHEREAS this conflict has displaced over a million Ukrainian people; and

WHEREAS the province of Manitoba has strong interpersonal, cultural, and historical connections with the country and people of Ukraine; and

WHEREAS Ukrainian immigrants have helped shape and build Manitoba; and

WHEREAS the province and good people of Manitoba are outraged at the conflict in Ukraine and wish to step up and assist Ukrainians in any way; and

WHEREAS the Provincial Government has provided financial support for humanitarian aid to the people of Ukraine through the Ukrainian Canadian Congress; and

WHEREAS immigration to Canada requires a coordination between Ukraine, Provincial, and Federal levels of Government in Canada; and

WHEREAS Manitoba continues to support the independence and territorial integrity of Ukraine.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba be urged to call on the Provincial Government to waive the fee for Ukrainians under the Manitoba Provincial Nominee Program, in order to reduce barriers for Ukrainians citizens fleeing the conflict and to expedite their journey, and to collaborate with the Federal Government in assisting Ukrainians who seek safety and refuge in Manitoba.

Mr. WIEBE – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

MLA ASAGWARA – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

Mr. BRAR – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

Mr. MALOWAY – To urge the Provincial Government to immediately demand Dynacare maintain all the phlebotomy (blood sample) sites existing prior to the Covid-19 public health emergency, and allow all Manitobans to get their blood and urine tests done when visiting their doctor, thereby facilitating local access to blood testing services.

Hon. Mr. GERRARD – To urge the Provincial Government to undertake a combined review of the Vivian Sand Facility processing plant and the mining/extraction portion of the operation as a Class 3 development with a review by Manitoba's Clean Environment Commission to include public hearings and participant funding and; to urge the Provincial Government to halt all activity at the mine and plant until the Clean Environment Commission's review is completed and the project proposal has been thoroughly evaluated.

Ms. FONTAINE – To urge the Provincial Government to immediately ensure effective and safe access to abortion services for individuals regardless of where they reside in Manitoba and to ensure that buffer zones are immediately legislated.

MLA MARCELINO – To urge the Provincial Government to take action to reduce people's exposure to lead in Winnipeg and to implement the recommendations proposed by the Provincial Government's independent review, including the creation of an action plan for the Weston neighbourhood, developing a lead awareness, communications and outreach program, requisitioning a more in-depth study and a creating a tracking program for those tested for blood lead levels so that medical professionals can follow up with them.

Mr. Moses – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

Ms. NAYLOR – To urge the Provincial Government to support a declaration that the first week in February of each year be known as Eating Disorders Awareness Week.

Mrs. SMITH (Point Douglas) – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

I have been informed of a proposed Bill, The Interim Appropriation Act, 2022, which will provide interim authority to make expenditures from the Consolidated Fund effective April 1, 2022 pending approval of The Appropriation Act, 2022.

The Bill also provides for payments to develop or acquire inventory and against certain liabilities accrued and unpaid as of March 31, 2022. The Bill will also provide a portion of commitment authority for future years.

I recommend the proposed Bill to the Legislative Assembly.
