Mr. KHAN moved:

Resolution No. 25: Calling on the Federal Government to Stand in Unity with the Manitoba Legislature and Support Human Rights of Iranian Protesters

WHEREAS on September 16<sup>th</sup> 2022, Mahsa Amini was arrested by Iranian Police and killed as a result of the police brutality she faced; and

WHEREAS in the last 43 years, the regime has led campaigns of discrimination against women, LGBTQ community, followers of other belief systems and other ethnic minorities; and

WHEREAS since then Iranian people have taken to the streets to protest the despotic government of the Islamic Republic of Iran; and

WHEREAS the women, men, and children of Iran have shown incredible bravery and protested the dictator rule with valour; and

WHEREAS the Members of this Legislature support freedom of choice and freedom of expression; and

WHEREAS Members of this Legislature stand for justice, and all human rights; and

WHEREAS Members of this Legislature stand with the people of Iran, Mahsa Amini and all women, men, and children to have their basic human rights, including the right to life, liberty and security.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba call on the Federal Government to stand with the people of Iran and adequately support Iranians and work to protect the people of Iran.

Pursuant to Rule 28(1), Messrs. SCHULER and WIEBE, Hon. Mr. PIWNIUK, Mr. ALTOMARE and Ms. LAMOUREUX made Members' Statements.

By leave, the House reverted to Ministerial Statements.

Hon. Ms. GORDON, the Minister of Health, made a statement regarding Health Care Aide Day.

MLA ASAGWARA and, by leave, Ms. LAMOUREUX commented on the statement.

Mr. ALTOMARE – [English version of a bilingual Petition] To request the Minister of Labour, Consumer Protection and Government Services to consider granting the auditorium to the JRL by March 1st, 2023; to request the Minister of Education to recognize the value that JRL provides to the student population of EHS as well as the communities of Village de St Pierre Jolys and the RM De Salaberry; to request the Minister of Education and the Minister of Francophone Affairs to recognize that an MOU between the RRVSD and JRL is morally, financially and culturally beneficial; to request the Minister of Sport, Culture and Heritage to recognize the heritage potential of this important building and its status in the community; and to request the Minister of Sport Culture and Heritage to prevent any renovations to the auditorium that would destroy and devaluate the architectural integrity of the building.

Ms. LATHLIN – To urge the Minister of Infrastructure to complete an assessment of PR 224 and implement the appropriate repairs using public funds as quickly as possible.

Mr. MALOWAY – To urge the new Premier to financially assist the City of Winnipeg on building this three-lane bridge in each direction to maintain this vital link between northeast Winnipeg, Transcona and the downtown; to urge the Provincial Government to recommend that the City of Winnipeg keep the old bridge fully open to traffic while the new bridge is under construction; and to consider the feasibility of keeping the old bridge open for active transportation in the future.

Mrs. SMITH (Point Douglas) – [English version of a bilingual Petition] To request the Minister of Labour, Consumer Protection and Government Services to consider granting the auditorium to the JRL by March 1st, 2023; to request the Minister of Education to recognize the value that JRL provides to the student population of EHS as well as the communities of Village de St Pierre Jolys and the RM De Salaberry; to request the Minister of Education and the Minister of Francophone Affairs to recognize that an MOU between the RRVSD and JRL is morally, financially and culturally beneficial; to request the Minister of Sport, Culture and Heritage to recognize the heritage potential of this important building and its status in the community; and to request the Minister of Sport Culture and Heritage to prevent any renovations to the auditorium that would destroy and devaluate the architectural integrity of the building.

MLA MARCELINO – To urge the Minister of Health and the Minister of Seniors and Long-Term Care to immediately increase investment in homecare services so that homecare workers can be paid a fair wage and clients can receive the level of service they require.

Mr. WIEBE – To urge the Minister of Transportation and Infrastructure to consult with noise specialists and other experts to help determine the most effective way to reduce the traffic noise and to commit to meaningful action to address resident concern; and to help address this issue with a noise barrier wall along residential portions of the South Perimeter from St. Anne's Road to St. Mary's Road and for River Park South residents.
