

The Deputy Clerk formally advised the Assembly that the Speaker was unavoidably absent and called upon the Assistant Deputy Speaker to take the Chair pursuant to the Statutes. The Assistant Deputy Speaker took the Chair at 10:00 a.m.

Hon. Mr. GERRARD moved:

THAT Bill (No. 238) – The Personal Care Home Accountability Act (Various Acts Amended)/Loi sur la responsabilisation des foyers de soins personnels (modification de diverses lois), be now read a Second Time and be referred to a Committee of this House.

The Bill was accordingly read a Second Time and referred to a Committee of this House.

The House resumed the debate on the Proposed Resolution of Mr. MICHALESKI:

Resolution No. 9: Calling on the Federal Government to Absorb the Cost of Increased RCMP Salaries

WHEREAS crime rates have been steadily rising in Canada as a result of "soft on crime" Liberal-NDP Coalition policies; and

WHEREAS municipalities are paying more for R.C.M.P. services due to the Federal Government negotiating a huge increase in the salary of the members of the RCMP without consulting with these communities; and

WHEREAS this wage increase is adding stress to the already limited budgets that municipalities must manage to provide services to Manitobans; and

WHEREAS the Association of Manitoba Municipalities have stated that this 23.7 percent wage increase is going to negatively impact all municipalities; and

WHEREAS the R.C.M.P. play a major role of creating safer streets and neighborhoods for Manitoba families; and

WHEREAS the provincial NDP, federal NDP and federal Liberals have made comments with "defund the police" attitudes; and

WHEREAS these attitudes are negatively impacting the relationship governments have with law enforcement officials; and

WHEREAS the Federal Government has the ability and the means to send these municipalities funding in order to fund their local police forces; and

WHEREAS all Members in this House should agree that there is a need to increase funding for police services, and not defund them, in order to adequately tackle rising crime due to NDP and Liberal soft on crime policies across Canada.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba call on the Federal Government to adequately and fairly fund the R.C.M.P. and the increased wage that it negotiated rather than putting that burden on Manitoba's municipalities.

Review

16.1(1) Within two years after the coming into force of this section, the minister appointed by the Lieutenant Governor in Council to administer the amendments enacted by section 13 of this Act must undertake a comprehensive review of this Act, which must include public representations.

Tabling report in Assembly

16.1(2) Within one year after the review is undertaken or within any longer period that the Legislative Assembly allows, the minister referred to in subsection (1) must table a report on the review in the Assembly.

Hon. Mr. SMITH (Lagimodière), the Minister of Municipal Relations, made a statement regarding Community Foundations Day.

Ms. NAYLOR and, by leave, Ms. LAMOUREUX commented on the statement.

Hon. Ms. GORDON, the Minister of Health, made a statement regarding Cystic Fibrosis.

MLA ASAGWARA and, by leave, Hon. Mr. GERRARD commented on the statement.

Pursuant to Rule 28(1), Hon. Mr. REYES, Mrs. SMITH (Point Douglas) and Messrs. HELWER, BRAR and LAMONT made Members' Statements.

The following petitions were presented and read to the Legislative Assembly of Manitoba:

Mr. ALTOMARE – To urge the Provincial Government to immediately provide comprehensive and free healthcare coverage to all residents of Manitoba regardless of immigration status, including refugee claimants, migrant workers, international students, dependent children of temporary residents, and undocumented residents; to urge the Minister of Health and Seniors Care to undertake a multilingual communication campaign to provide information on expanded coverage to all affected residents; to inform all healthcare institutions and providers of expanded coverage for those without health insurance and the details on how necessary policy and protocol changes will be implemented, and to create and enforce strict confidentiality policies and provide staff with training to protect the safety of residents with precarious immigration status and ensure they can access health care without jeopardizing their ability to remain in Canada.

Mr. MALOWAY – To urge the Provincial Government to immediately demand Dynacare maintain all the phlebotomy (blood sample) sites existing prior to the Covid-19 public health emergency, and allow all Manitobans to get their blood and urine tests done when visiting their doctor, thereby facilitating local access to blood testing services.

Mr. REDHEAD – To urge the Provincial Government to provide the services of two nurses to restore essential medical foot care treatment to the City of Thompson effective April 1, 2022.

Mrs. SMITH (Point Douglas) – To urge the Provincial Government to enact Bill 217 – The Fatality Inquiries Amendment Act (Overdose Death Reporting), to require the province to publish the number of drug overdose death, as well as the type of drug, on a government website in a timely fashion.

In accordance with Rule 34(7), the Government House Leader announced that the Private Members' Resolution titled "Committing to Balancing Future Budgets while Keeping Life Affordable for Manitoba Families" will be considered on the next Tuesday of Private Members' Business.

The House resolved into Committee of Supply.

The House then adjourned at 5:00 p.m. until 1:30 p.m. Wednesday, May 10, 2023.
