The Speaker then informed the House that Ms. Josie AUCH, Mr. Karson CRAVEN, Mses. Sukhmeet Kaur GHATRORHE, Chielo JOSE and Gurreet Kaur KHELA, Mx. Chey PERRAULT-KEEPER and Mses. Anna KERSEY, Sehajveer Kaur SIDHU and Milena ZAIATS had been appointed Pages, and Ms. Kathryn SACHER had been appointed Senior Page, for the Second Session of the Forty-Third Legislature.

The following petitions were presented and read to the Legislative Assembly of Manitoba:

Mr. Khan – To urge the Provincial Government to cancel drug-injection sites in the Point Douglas community, including the proposed location at 200 Disraeli Freeway; and to legislate that no future site will be proposed without community support.

Ms. BYRAM – To urge the Provincial Government to immediately work with the RCMP to restore rural community policing and provide adequate resources to protect Manitoba communities.

Mr. JOHNSON – To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.

Mrs. STONE – To urge the Government of Manitoba to immediately work with the Prairie Rose School Division to begin the process of replacing the gymnasium facilities at the Elm Creek School, in consultation with parents and the community.

- MLA BEREZA To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.
- Mr. PERCHOTTE To urge the Minister of Transportation and Infrastructure to prioritize the reconstruction of Provincial Road 210; and to urge the Provincial Government to include the stretch of Provincial Road 210 from Woodridge to Highway 12 in its reconstruction plans.
- Mr. Schuler To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.
- Mrs. ROBBINS To urge the Provincial Government to remove the federal carbon tax on home heating bills for all Manitobans to provide them much needed relief.
- Mr. Wharton To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.
- Mr. WOWCHUK To urge the Minister of Transportation and Infrastructure to take the necessary steps to upgrade Provincial Trunk Highway 45 from Russell to Provincial Trunk Highway 10 to meet RTAC standards.
- Mr. NESBITT To urge the Minister of Transportation and Infrastructure to take the necessary steps to upgrade Provincial Trunk Highway 45 from Russell to Provincial Trunk Highway 10 to meet RTAC standards.
- Mr. GUENTER To urge the Provincial Government to lobby the Federal Government to develop and implement a comprehensive plan to assist border communities in managing the rise in illegal border crossings into Manitoba; to work closely with federal and local authorities to ensure adequate resources, including funding and support for emergency services, are available to protect local communities; and that immediate measures be taken to dismantle and destroy all human smuggling networks operating in Manitoba.
- Mrs. Cook To urge the Provincial Government to proceed with the planned renovation and expansion of Phoenix School without further delay.
- Mr. BALCAEN To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

Mr. EWASKO – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

Mr. PIWNIUK – To urge the Provincial Government to support Manitoba small businesses through specific funding to reimburse the expenses and insurance deductibles that they incur as a result of crime.

Mr. GOERTZEN – To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.

Mr. NARTH – To urge the Minister of Education and Early Childhood Learning to immediately bring back the three portable classrooms to help alleviate the stress and overcrowding classrooms; and to urge the Provincial Government to reinstate the expansion project for Green Valley School.

Mr. KING – To urge the Provincial Government to lobby the Federal Government to develop and implement a comprehensive plan to assist border communities in managing the rise in illegal border crossings into Manitoba; to work closely with federal and local authorities to ensure adequate resources, including funding and support for emergency services, are available to protect local communities; and that immediate measures be taken to dismantle and destroy all human smuggling networks operating in Manitoba.

Mrs. HIEBERT – To urge the Provincial Government to take immediate action and recognize the critical need of this wastewater project for economic growth and environmental stability by committing to advocating and working with the Federal Government to close the gap with additional funding for Morden's wastewater treatment system; and to ensure all levels of government and regulatory bodies will expedite necessary funding and approvals necessary to advance the Morden wastewater project with no further delay and ensure no hindrance to growth and economic development for Morden and southern Manitoba.
