Hon. Min. FONTAINE tabled:

Revised sequence for consideration of the Estimates by the Committee of Supply for November 6, 2025.

(Sessional Paper No. 139)

Pursuant to sub-rule 28(1), MLA DELA CRUZ, Mrs. STONE, MLA LAMOUREUX and Messrs. EWASKO and WASYLIW made Member's statements.

The following petitions were presented and read to the Legislative Assembly of Manitoba:

Mr. KHAN – To urge the Minister of Education and Early Childhood Learning to reverse recent amendments to the Teaching Certificates and Qualifications Regulation that weaken subject-area requirements for teacher certification, and to reinstate teachable majors and minors and early-middle years requirements, which are essential for ensuring teachers have strong knowledge in core subject areas; and to urge the Provincial Government to address teacher shortages through alternative measures that uphold rigorous subject-area standards, which are critical for providing quality education to all Manitoba students.

Mr. JOHNSON – To urge the Provincial Government to investigate the 911 network failures that contributed to the March 2025 tragedy in the Interlake region and to publicize those findings; and to work with municipalities, telecommunications providers, and first responders to strengthen 911 reliability and ensure uninterrupted access to emergency services for all Manitobans—especially those living in rural and northern communities.

Mrs. COOK – To urge the Provincial Government to proceed with the planned renovation and expansion of Phoenix School without further delay.

Mr. KING – To urge the Minister of Transportation and Infrastructure to immediately restore funding to the PR227 paving project; and to commitment to Manitobans to carry out all of the projects, as outlined in the 2023 Multi-year Infrastructure Investment Strategy, in their totality, to the same scope and in accordance with already stated timelines.

Mr. BALCAEN – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

MLA BEREZA – To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.

Mr. EWASKO – To urge the Provincial Government to remove the federal carbon tax on home heating bills for all Manitobans to provide them much needed relief.

Mr. GOERTZEN – To urge the Provincial Government to support the investment and placement of an MRI machine in the Portage Regional Health Facility in Portage la Prairie, Manitoba.

Mr. GUENTER – To urge the Provincial Government to lobby the Federal Government to stop the expansion of medical assistance in dying to those for whom mental illness is the sole condition; and to protect Canadians struggling with mental illness by facilitating treatment, recovery, and medical assistance in living, not death.

Mrs. HIEBERT – To urge the Provincial Government to cancel drug-injection sites in the Point Douglas community, including the proposed location at 200 Disraeli Freeway; and to legislate that no future site will be proposed without community support.

Mr. NARTH – To urge the Minister of Transportation and Infrastructure to prioritize the reconstruction of Provincial Road 210; and to urge the Provincial Government to include the stretch of Provincial Road 210 from Woodridge to Highway 12 in its reconstruction plans.

Mrs. ROBBINS – To urge the Provincial Government to address the conditions of Provincial Trunk Highway 34, making the necessary upgrades to RTAC standard and to resurface the road once the new bridge has been completed.

Hon. Min. FONTAINE, for Hon. Ms. SMITH, moved:

THAT Bill (No. 48) – The Protective Detention and Care of Intoxicated Persons Act/Loi sur la détention des personnes agissant sous l'influence d'une substance intoxicante aux fins de protection et de prestation de soins, reported from the Standing Committee on Social and Economic Development, be concurred in and be now read for a Third Time and passed.
