

DEBATE ON GOVERNMENT MOTION:

Hon. Min. FONTAINE – Special Committee on Local Journalism

THAT a Special Committee on Local Journalism be created to make recommendations on exploring the future of local journalism, including rural and cultural media such as French, Filipino, Punjabi and Chinese language publications, with the mandate to consider matters of public support for journalism, and report its conclusion to the Assembly within 30 days of the start of Fall Sitting 2025; and

THAT the composition of the Special Committee be:

- (a) four members designated by the NDP caucus, and
- (b) two members designated by the PC caucus; and

THAT the Special Committee be authorized to decide how it will conduct its business, including deciding to hold meetings at times and places it considers advisable to receive briefs and hear presentations; and

THAT, except as otherwise provided in this motion, the Special Committee shall have the same status and powers and follow the same rules and procedures as a Standing Committee of the House, including the power to establish a sub-committee for the purposes of carrying out any part of the Special Committee's work; and

THAT after adoption by the House, this motion may be amended only by:

- (a) unanimous consent of the House;
- (b) passage of a subsequent motion by the House; or
- (c) written agreement of all House Leaders if the House is not sitting.

And the Proposed Motion of Mr. JOHNSON in amendment thereto as follows:

THAT the first clause of the Motion be deleted and the following substituted as the new first clause:

THAT a Special Committee on Local Journalism be created to make recommendations on exploring the future of local journalism, including rural and cultural media representing all ethnicities and non-official languages, so long as they do not promote hate speech or undermine the Manitoba values of inclusivity and respect for all races, religions, and backgrounds, with the mandate to consider matters of public support for journalism, and report its conclusion to the Assembly within 30 days of the start of Fall Sitting 2025; and

7. The Minister of Advanced Education and Training has allocated letters to allow international students to study at Manitoba institutions. Will the Minister provide for this House a breakdown of exactly how many attestation letters each institution has been allocated for the 2024/2025 academic year, compared to how many international students the same institution had in the 2023/24 and 2022/23 academic years?
 8. Can the Minister of Advanced Education and Training explain how the Provincial Government plans to ensure that Manitoba's post-secondary institutions remain financially sustainable without placing the burden on students through tuition hikes?
 9. How is the Provincial Government ensuring that Manitoba's rich Indigenous and Métis history is meaningfully integrated into heritage preservation and tourism initiatives?
 10. Modernizing the Film and Video Production Tax Credit by providing upfront cash advances aims to attract production companies to Manitoba. Given the ongoing trade tensions and the imposition of U.S. tariffs, how does the Provincial Government plan to ensure that these changes will continue to benefit Manitoba's local economy and film industry; specifically, how will the revitalized tax credit support the province in attracting international film productions despite the challenges posed by these tariffs?
 11. The Selkirk Bridge, which was built in 1935, is now approaching 90 years old and needs to be replaced to meet current and future traffic demands. The Minister of Transportation and Infrastructure provided an update in October of 2024, indicating that the preliminary design phase was ongoing, with completion expected by June 2025. Can the Minister provide a clear timeline for when the replacement project will be completed?

Mr. NARTH – Recognizing Providence University College and Theological Seminary's 100th (Centennial) Anniversary

9. WHEREAS the year 2025 marks the 100th anniversary of Providence University College and Theological Seminary (Providence), an institution that has provided high quality, faith-centered post-secondary education in Manitoba since its founding in 1925 as the Winnipeg Bible Training School; and

WHEREAS Providence has grown from its humble beginnings in a house on Spence Street in Winnipeg, to a 100-acre campus in Otterburne and a new downtown campus in Winnipeg, enabling it to serve students from across Manitoba, Canada, and beyond; and

WHEREAS Providence was the first Bible school in Canada to grant bachelor's degrees in 1948, and has played a significant role in Manitoba's educational landscape by expanding program offerings, including aviation, business, science, and theological studies; and

WHEREAS Providence has served over 12,000 students over the past century, many of whom have gone on to contribute significantly to their communities, churches, and professions in Manitoba and across the world; and

WHEREAS Providence will host a centennial celebration weekend in commemoration of this historic milestone from September 5 to 7, 2025, featuring a gala, festival, and worship events to honour its rich historical legacy and ongoing mission of equipping students for leadership and service and helping them to understand their calling in a changing world.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba recognize and congratulate Providence University College and Theological Seminary on its 100th anniversary and commend its enduring contributions to higher education, leadership, and faith-based learning in the province.
