

The following corrections to the [2024 Manitoba Hunting Guide](#) include:

- Dates in note (page 26)
  - mule deer hunters in GHA 5, 6, 6A and 11 **between Sept 16 and Oct 13** (incorrectly noted as Sept 18 and Oct 15)
  - mule deer bowhunters in GHA 13 or 18 between **Aug 26 and Sept 15** (incorrectly noted as Aug 28 and Sept 17)
- Dates in note (page 29)
  - general white-tailed deer hunters in GHA 5, 6, 6A, 7, 8, 10, 11, 15, 15A between **Sept 16 and Oct 13** (incorrectly noted as Sept 18 and Oct 15)
  - white-tailed deer bowhunters in GHA 13 or 18 between **Aug 26 and Sept 15** (incorrectly noted as Aug 28 and Sept 17)
- Date for general deer (archery) in Zone D (note on page 30)
  - **Nov 10** (incorrectly noted as Nov 12)
- Date for moose general (rifle) for Manitoba resident hunters in GHAs 1, 2, 3, 3A (page 41)
  - **Aug 26** (incorrectly noted as Aug 22)
- Daily bag limit and possession limit for Sandhill Cranes for Manitoba resident and Canadian resident hunters (page 61)
  - **daily bag limit of 5 and possession limit of 15** (incorrectly noted as daily bag limit of 8 and possession limit of 24)
- Dates to Morning-only dark goose hunting for non-Canadian resident hunters: In GBHZ 4 and GHAs 13A, 14, 14A, part 16, 18, 18A, 18B, 18C, 19, 19A, 19B, 20, 21A, 23A, and 25 dark goose hunting is restricted to morning only (note section on page 61)
  - Up to and including **Oct 13** (incorrectly noted as Oct 8)
  - **Oct 14**, dark geese may be hunted all day (incorrectly noted as Oct 9)
- Date to white geese (snow) for non-Canadian resident hunters in GBHZ 3 and 4 (page 61)
  - Starting **Sept 17** (incorrectly noted as Sept 24)

**Discrepancy between Federal and Provincial Regulation regarding the daily bag limit and possession limit of dark geese for non-Canadian Residents:**

- **The daily bag limit of 5 and possession limit of 15 Dark Geese for non-Canadian Residents shall apply.**
- The non-Canadian resident section of the MIGRATORY GAME BIRD HUNTING SEASONS table found on page 61 in the 2024 Manitoba Hunting Guide (and the Manitoba Hunting Seasons and Bag Limits Regulation 165/91) states the daily bag limit for Dark Geese (Canada, White-front, Brant and Cackling) for Game Bird Hunting Zone (GBHZ) 2, 3 and 4 is noted as 8 and possession limit is 24.
- This is not consistent with the federal [Migratory Birds Regulations, 2022](#) and the federal [Summary of Migratory Birds Hunting Regulations: Manitoba, August 2024 to July 2025](#) which has a daily bag limit is 5 and possession limit is 15.
- Federal regulations prevail over the provincial regulations.
