THIS LICENCE IS ISSUED TO:

**THE PROVINCE OF MANITOBA REPRESENTED BY THE MINISTER OF
HIGHWAYS AND TRANSPORTATION**
The "Licencee"

for the construction and operation of the Development being the upgrading of Provincial Road #210 from Provincial Road #200 to Provincial Trunk Highway #59 located in the Rural Municipality of Ritchot subject to the following specifications, limits, terms and conditions:


SPECIFICATIONS, LIMITS, TERMS, AND CONDITIONS

- 1) The Licencee shall construct the Development in accordance with the *Environment Act Proposal Proposed Upgrading of Provincial Road #210 (from PR 200 to PTH #59)*, filed by the Department of Highways and Transportation, dated January 20, 1995.
- 2) The Licencee shall, prior to final design and construction of the Development, submit an Engineering Report to the Director for approval. The Report shall:
 - a) contain the results of an assessment of the impact of the project on the 1979 and 100 year flood conditions in the Town of St. Adolphe and existing rural residences adjacent to the Development;
 - b) recommend measures to mitigate any impacts from the Development on the 1979 and the 100 year flood conditions in the Town of St. Adolphe and the existing rural residences adjacent to the Development, as identified in the Report.
- 3) The Licencee shall construct, as part of the Development, the measures to mitigate any impacts from the Development on the 1979 and 100 year flood conditions, as identified in the Report.
- 4) The Licencee shall, during the spring runoff period of each year during construction, cease all construction activities that may impact upon the St. Adolphe Coulee riparian zone.
- 5) The Licencee shall, during construction, maintain the profile of the St. Adolphe Coulee banks upstream of the Development.
- 6) The Licencee shall, during construction, use erosion control measures on disturbed areas of the St. Adolphe Coulee riparian zone.

- 7) The Licencee shall, during the rehabilitation of any timber bridges related to the Development, not use timbers treated with creosote or pentachlorophenol.
- 8) The Licencee shall, during construction, ensure that fuel storage areas established for the construction of the Development are located a minimum distance of 100 meters away from the high water line of the St. Adolphe Coulee and shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products*.
- 9) The Licencee shall, at the completion of construction, cleanup the construction area and deposit all resulting debris at a registered Municipal Waste Disposal Ground operating under the authority of a permit pursuant to the Waste Disposal Grounds Regulation, Manitoba Regulation 150/91.
- 10) The Licencee shall, at the completion of construction, landscape and vegetate all areas disturbed during construction with native and/or introduced plant species in order to restore and enhance the site and to protect against erosion.

REVOCATION

If in the opinion of the Director the Licencee has not complied or is not complying with the specifications, limits, terms or conditions set out herein, the Director may revoke, temporarily or permanently, this Licence.
