AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION
UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and Canada Packers Inc., Applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, Canada Packers Limited submitted an application to The Clean Environment Commission to prescribe limits in connection with the operation of a beef and hog slaughtering and processing plant including inedible rendering and blood drying, located on 13.3 acres of 310 Block G, Plan 433, Roman Catholic Mission Property, at or near 660 Marion Street, in the City of Winnipeg, Manitoba;

AND WHEREAS a representation was made to The Clean Environment Commission by a person who is or is likely to be affected by an order of the Commission prescribing limits in connection with the said operation;

AND WHEREAS the Commission held a public hearing in Winnipeg on the 26th, 27th and 28th days of June, 1973;

AND WHEREAS the Commission considered the said application on the 22nd day of January, 1973, and issued Order No. 237 on the 22nd day of January, 1973;

AND WHEREAS on the 10th day of May, 1974, the Applicant submitted a request for variation of the said order to the Commission;

AND WHEREAS the Commission held a hearing in Winnipeg on the 15th day of July, 1974, for the purpose of hearing evidence in connection with the request for variation and issued varied order No. 237V on the 23rd day of September, 1974;

AND WHEREAS on the 25th day of April, 1984, the Applicant submitted a request for variation of Order No. 237V to the Commission;

AND WHEREAS the Commission held a hearing in Winnipeg on the 15th day of October, 1984, to receive evidence and representations concerning the request for variation;

AND WHEREAS the Commission considered the request for variation on the 23rd day of October, 1984;

IT IS HEREBY ORDERED THAT ORDER NO. 237V BE VARIED TO READ AS FOLLOWS

1. The Applicant shall, at all times except during equipment closures undertaken pursuant to 4(c), limit the emission of odours from the said operation to such an extent that odours emitted from the inedible rendering cookers and/or blood driers, when sampled in exhaust gas withdrawn at a sampling port located at or near the point of emission are not detectable when one volume of exhaust gas is diluted with 149 volumes of odour-free air.
2. The Applicant shall, at all times except during equipment closures undertaken pursuant to 4(c), limit the emission of odours from the said operation to such an extent that odours from the said operation, when sampled at any point of impingement off plant property, are not detectable when one volume of odorous air is diluted with six equal volumes of odour-free air.
3. The Applicant shall provide sampling ports in conformity with the requirements of the Environmental Management Division.
4. The Applicant shall
 - (a) maintain all odour control and reduction equipment and facilities in sound operating condition;
 - (b) subject to (c), operate all odour control and reduction equipment and facilities continuously whenever or however the said cookers and/or blood driers are in operation;
 - (c) not more than once between the 14th day of March and the 16th day of April and not more than once between the 14th day of October and the 16th day of November of any year, the Applicant may take the said odour control equipment out of operation to carry out essential maintenance and repairs for periods not in excess of three days on each occasion, without closing down the said cookers and blood driers during such three day periods.
5. The Applicant shall maintain a high standard of equipment maintenance and good housekeeping in the said operation consistent with meeting the limits, terms and conditions prescribed in this order.

6. Order No. 237V, as varied by the Commission, is hereby designated as Order No. 237VCC.
