### Hi Cory and Asit,

#### My concerns are:

- 1. The NE side of the "Development Area" looks to be adjacent the closed waste disposal ground (p.3 of EAP). I don't know exactly where the edge of the closed cell is, but this is overlapping on the one side of butting up next to it.
- 2. What is the leachate ditching system going to be compacted too (or constructed with), if there's not enough clay to line the bottom of the ponds?
- 2. The plan is to build 4 ponds and the bottoms of the ponds will be dense till, while the walls will be clay. Why don't they line the ponds with geosyntetic liner?
- 3. The plan is to truck haul the biosolids after they have been dewatered by 19%. What does 19% mean? If this is still quite wet, will the truck/trailer have a liner to prevent leakage and spillage during transport?
- 4. They want to collect leachate form the ponds into a holding tank. But no details have been provided on the tank, or the type of hauler. It is going to be hauled back to the WWTF.
- 5. A perimeter ditch should be constructed to keep surface water out of the leachate collection system.
