Thank you for submitting the Notice of Alteration (NoA) regarding the Humanitarian Search Project at the Brady Road Resource Management Facility on behalf of the City of Winnipeg.

The department has completed its review of the NoA (attached) and requests clarification on the following points:

- 1. Does the reported 22,466 m³ of waste material in Section 3.1 include both overburden and cover material? Yes, it includes both. We are working on refining this information to better delineate the volume of overburden from waste through the targeted zone assessment and that will be provided to EAB once calculated.
- 2. Please confirm, in metres, the vertical distance between the liner and the leachate collection system from the proposed bottom of the excavation pit. The bottom of the leachate collection in cell 32 is at 229 m.
- 3. Kindly provide a layout map identifying the proposed disposal location for the excavated ACM materials, along with the available airspace at that location. The intention of Area D was to put the entirety of the overburden removed for the search into this area which would include any ACM or SRM encountered. If any ACM or SRM is encountered, it will be handled and isolated in Area D as per our best practices and Environmental Act License based off the fill progress of the overburden removed.

4. Kindly provide a layout map identifying the proposed disposal location for the excavated SRM materials, along with the available airspace at that location. See response above.
