Dear Ms. Burland Ross:

The City is requesting revision to Environmental Approvals, Licence No. 3121 E, Clause 13 which states: “The Licencee shall implement the drainage plan outlined in the report submitted to the Director of the Environmental Approvals Branch on June 18, 2015 titled “Southwest Transitway - Stage 2, Additional Information on Drainage and Natural Areas in the Parker Lands””. The section of berm running east from the AT path to the north of the station and then running towards the CN property on the west side of the pond has not been built. This final section of berm, as described in the attached, is not required due to sufficient elevation to prevent drainage. We are requesting your concurrence that the highlighted berm is not required as originally presented in the June 18, 2015 report.

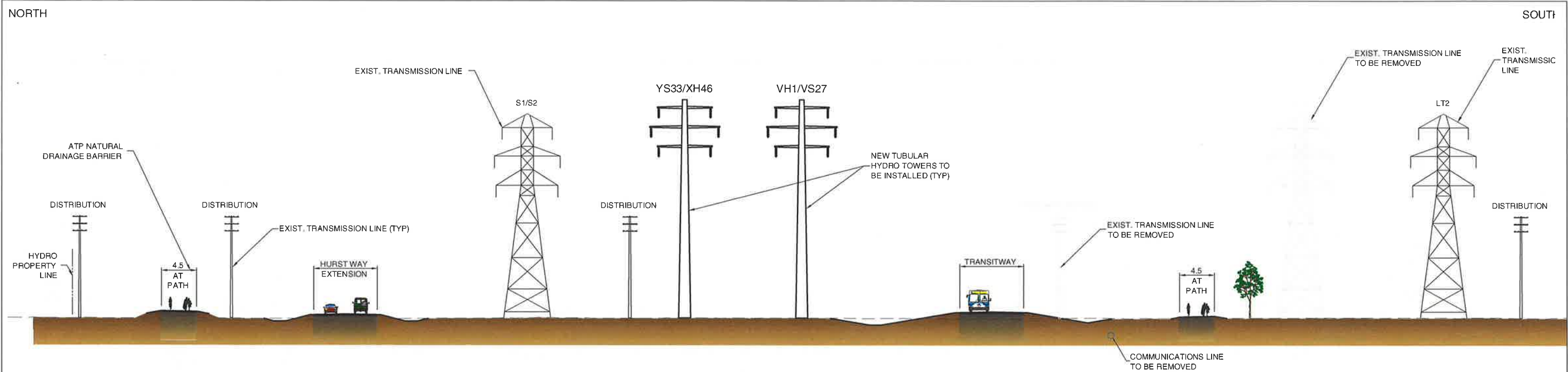
← PERMIT ACCESS POINTS DURING CONSTRUCTION

NOTE: OPERATIONAL ACCESS POINTS AFTER CONSTRUCTION FROM TRANSITWAY ONLY

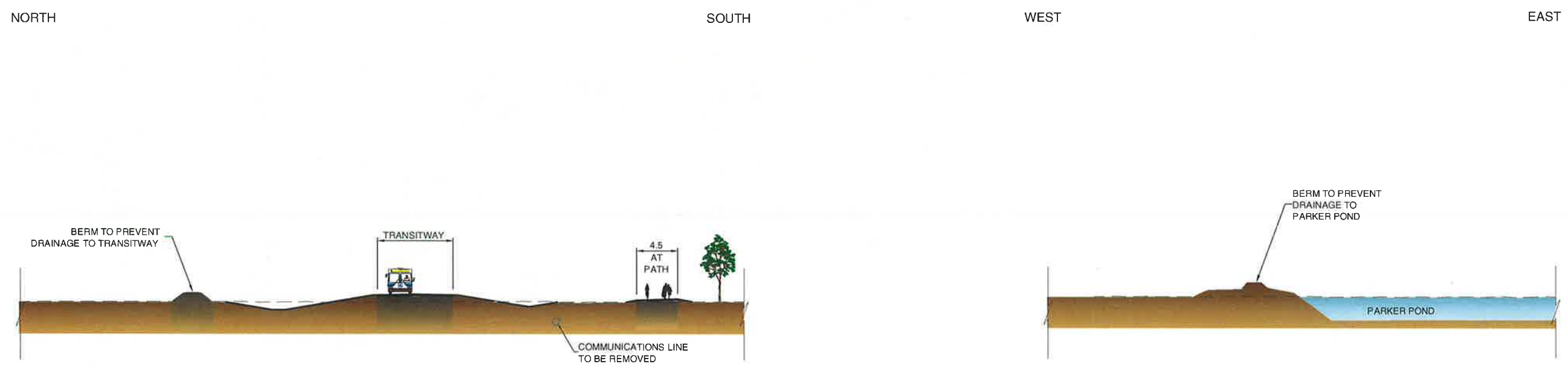

In response to your request, Dillon Consulting Limited (Dillon) is pleased to provide the following documentation with respect to seeking an amendment to Environment Act Licence No. 3121 E Clause 13.

Environmental Approvals, Licence No. 3121 E, Clause 13 states: "The Licencee shall implement the drainage plan outlined in the report submitted to the Director of the Environmental Approvals Branch on June 18, 2015 titled "Southwest Transitway - Stage 2, Additional Information on Drainage and Natural Areas in the Parker Lands"". To date, the contractor (PCL) has built the Active Transportation (AT) path from the Humane Society (far left on Figure EIA-003, attached) parallel to Hurst Way to the north and then parallel to Georgina Street to the east and tying it into the Beaumont Station (which is labelled Parker Station on Figure EIA-003 as this drawing was produced prior to the name change). The section of berm running east from the AT path to north of the station and then running towards CN property on the west side of the pond has not been built (highlighted on Figure EIA-003).

In addition, the owner of the lands to the north of the AT path (known as the GEM lands) has cleared all the trees on their property and has brought in thousands of cubic metres of fill material. This has significantly changed the natural features and use of the area.

Dillon has assessed the construction progress along with the recent information provided by the contractor. Based on this review, Dillon is in agreement that the final section of berm (highlighted on Figure EIA-003) is not required due to sufficient elevation to prevent drainage as well as the changes to the surrounding lands.

This information has been discussed with Ms. Elise Dagdick of Manitoba Sustainable Development in December with follow-up in January. She has indicated that her department is prepared to receive and review this request to amend Environmental Approvals, Licence No. 3121 E, Clause 13 in accordance with Figure EIA-003, deleting the berm highlighted on the drawing.
