999 Redonda Street, RM of Springfield**

Conservation and Climate acknowledges receipt of the Decommissioning Plan submitted by Tervita Corporation on January 19, 2021, and additional information submitted April 29, 2021, to fulfill Clause 93 of Dangerous Goods Handling and Transportation Act Licence no. 337 HW for the Redonda Hazardous Waste Facility located at 999 Redonda Street in the Rural Municipality of Springfield.

Upon review of the above documents, Conservation and Climate is satisfied with the assessment of remediation and closure plan and accept the total amount of \$114,985.00 Cdn as an estimated cost to the decommissioning the facility.

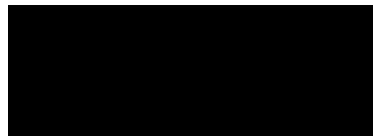
Please be advised of the following:

1. Upon closure of the facility, the director may require an investigation to be carried out in accordance with the Environmental Site Assessments in Manitoba - June 2016 guideline (or any future revision thereof), as per Clause 91, including at minimum a Phase II site assessment.

2. As per Clause 94, Tervita Corporation shall maintain and post with Conservation and Climate a permit bond, irrevocable letter of credit or another acceptable security satisfactory to the Director for \$114,985.00 Cdn which shall remain in place for the duration of the operation and decommissioning of the Facility.

3. This remediation and closure plan is to be reviewed as per the requirements specified in Clause 96.
4. Tervita Corporation shall maintain valid Environmental Impairment Liability insurance providing coverage subject to a minimum limit of \$1,000,000 Cdn per occurrence or claim, including coverage for gradual, and sudden and accidental pollution, as required in Clause 97.
