I am a resident of Oakbank, and am very concerned with the Silica Sand Mining that CanWestSands is proposing for SE Manitoba. After submitting their proposal to the environmental act, an unbiased science researcher identified 17 major concerns with their proposal!!

Last night, AECOM and CanWhiteSands held an open house. Interested parties were to email their questions and register to join their Zoom Open House. The entire event was biased and none of our concerns that were considered 'negative' were answered. People were 'accidentally' kicked out of the session and when they called back on the toll free line, questions were still not answered.

This project has been chopped into pieces to run under the radar of proper environmental studies and that is a true shame. There are so many contradictions from CanWhite Sands on the scope of the project. In some cases they state 25 years, in others they say 100 years. BEFORE you step down, I implore you and your colleagues to do the right thing. 50-60 additional jobs is NOT worth the possibility of having the largest environmental water disaster if their methods (which experts have questioned) contaminate the only water aquifer which supplies so many rural communities. Water IS NOT and should never be a commodity that is tradeable, it is a natural resource that should remain as such.

I hope and pray that your legacy will not be one that history will mark as the worst premier of Manitoba who cared more about the economy than the environment, but of one who did his job thoroughly and allowed experts to do their diligence and question mining methods that have never been done before in such a large scale project.

As a resident of the Rural Municipality of Springfield, I am writing to express my concern over the proposed silica sand processing facility and mine that is planned to be built in Vivian, Manitoba by the CanWhite Sands Corporation of Alberta. There is a high probability that the extraction effects from CanWhite Sands new and unproven mining methods will contaminate the Brokenhead River, Lake Winnipeg and an extremely large aquifer that supplies drinking water to over 64,000 people in the rural areas of Springfield, Tache, La Broquerie, Ste. Anne, Hanover, Reynolds, Brokenhead and the Brokenhead First Nations.

CanWhite Sands has indicated that there will be no impact to the aquifer or to fish-bearing waters but have yet to validate their claims.

How will you and your party protect our valuable aquifer, river, and lake?

Given that the CanWhite Sands extraction process is unconventional, will the Government of Manitoba consider conducting a Clean Environment Commission (CEC) hearing into the CanWhite Sands proposed silica sand mining operation?

Dear Honourable Guillemard,

Re: CanWhite Sands Corp. – Silica Sand Extraction Project – File 6119.00

Seven southeastern municipalities have established a Municipal Silica Sand Advisory Committee (MSSAC) to serve as an advisory body to the municipal council of each participating Municipality regarding independent review and obtaining of information to better understand the effects that may arise as a result of the silica sand extraction project proposed by CanWhite Sands Corp. Committee members are the rural municipalities of Tache, Ste. Anne, La Broquerie, Hanover, Brokenhead, and Reynolds, and the City of Steinbach.

Collectively, we respectfully request that a public hearing on this project, together with the proposed processing facility (File 6057.00 in the Public Registry) be conducted by the Clean Environment Commission. This project is very complex and the methodology for extraction appears to be unproven, and the potential for significant negative impacts to the groundwater resource in southeastern Manitoba is too risky not to have the project more fully scrutinized by the public, municipalities, subject matter experts and other interested parties. We feel that the Environment Act Proposal document is incomplete and leaves many unanswered questions about our precious water resource. There very well could be a way to safely extract silica sand from the sandstone aquifer, however this proposal does not demonstrate with any degree of certainty that what is being proposed will not have negative effects.

We have e-mailed separate correspondence directly to the Public Registry outlining many detailed comments and concerns on the silica sand extraction proposal.
