RE: Director's Order – Bakers Narrows Provincial Park Closure

Be it resolved that it is imperative that an issuance of a Director's Order, as Director of Parks, by way of section 27(1) of *The Provincial Parks Act*, is necessary to implement specific closures in provincial parks.

Due to significant risks associated with out-of-control wildfires adjacent to Bakers Narrows Provincial Park, an ongoing Closure Order is required for certain areas of the Park, including:

- Bakers Narrows Campground

Please see the attached Bakers Narrows Provincial Park Campground Closure Area map.

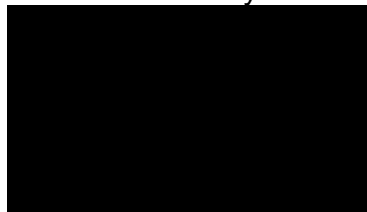
This new Closure Order will come into effect on Wednesday, June 25th, 2025, at 9 am.

During the period of the closure, no person should reside in or enter the park closure area unless otherwise authorized by Manitoba Parks.

This Director's Order under *The Provincial Parks Act* is in effect until such time as it is rescinded.

Be it further resolved that the below Director's Order for the closure and evacuation of Bakers Narrows Provincial Park, as issued on May 30th, 2025, is rescinded once this new Closure Order is effective.

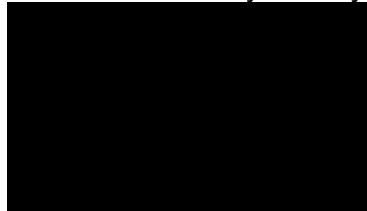
The closure will come into effect on Friday, May 30th, 2025, at 9:00 am.

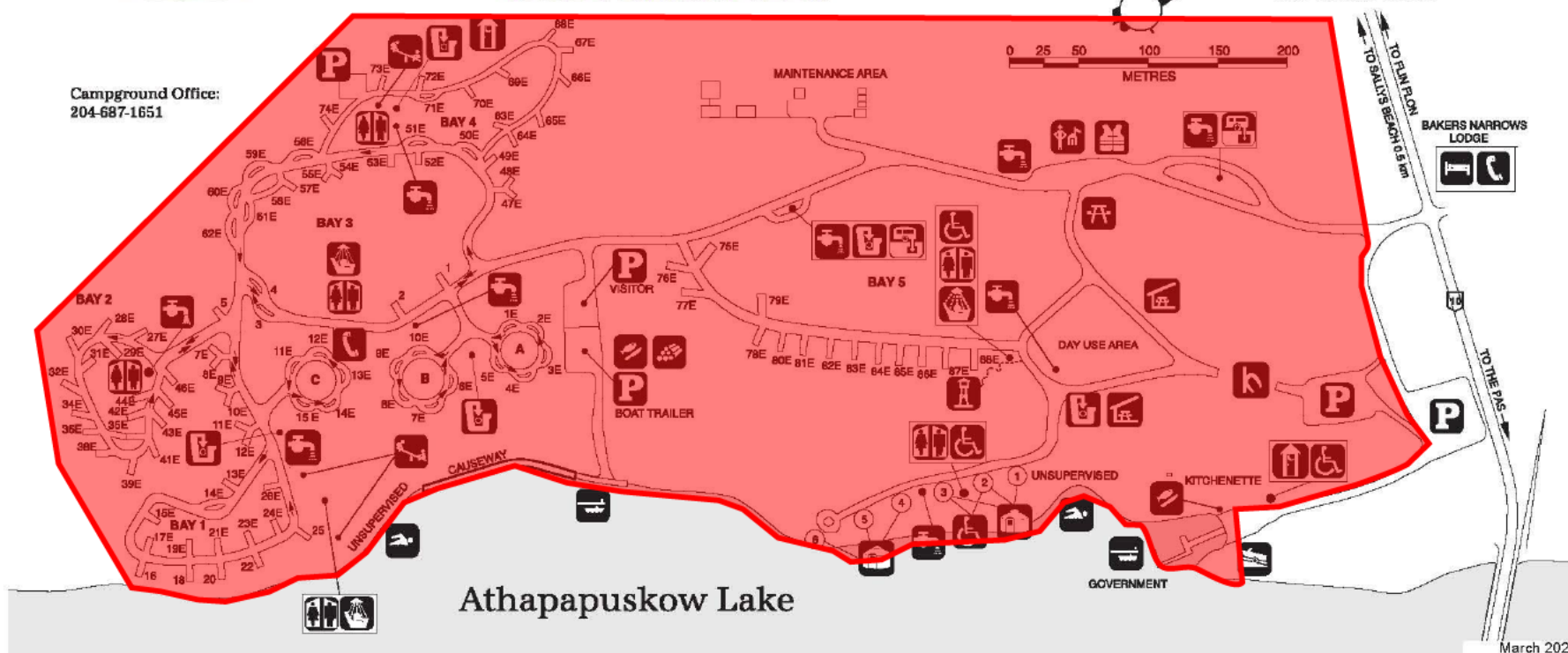
